A meeting of Board of Studies in Home Science was held on 28-7-2021 at 11.30 am in the Department of Home Science, University of Jammu.

Agenda Items:

Item 1: To confirm the minutes of the meeting of the Board of Studies in Home Science which was held on 08.05.2017, already circulated.

Resolved that the minutes of the meeting of Board of Studies in Home Science held on 08-05-2017, be confirmed.

Item 2: To review and modify the syllabi and Courses of Studies in the Subject of Home Science (Human Development) of Master Degree Programme for Semesters 1st to IVth under the Curriculum Reforms of RUSA 2.0 from the Academic session 2021-2022.

The syllabi and courses of study in the subject of Home Science (Human Development) of Master Degree Programme for semester I to VI was revised and the recommendations given by the experts in the meeting under "Curriculum reforms of RUSA 2.0" were taken into consideration after a threadbare deliberation in pre meeting of BOS followed by BOS meeting. It was resolved that the appended scheme and syllabi will be followed for the triennial period.

Item 3: To discuss the proposal, statutes and syllabus of B.Voc in Food Processing and Quality Management.

The proposal, statutes and syllabus of B.Voc in Food Processing and Quality Management was discussed with the Principal GDC, Udhampur, Prof. Farooq Masoodi, Department of Food Sciences and Technology (KU) and Dr. Ashwani Khajuria, GDC, Kathua (Special Invities). It was resolved that before commencement of the BVOC programme, Principal GDC, Udhampur shall seek following clarifications from the Higher Education Department of the UT of J & K:

- Title of the course
- Nature of the course, whether it is the BVOC or skill based course

- c) Duration of the course
- d) Date of commencement of the course
- e) To ensure that infrastructure is available for running the said course.

For the syllabi and courses of study in the subject of BA/BSc (Food Science and Quality Control) it was observed by the members of the board that at present the said course is not offered in any of the affiliated colleges of University of Jammu. However, it was brought to the notice of the board the Higher Education Department of the UT of J & K has sanctioned a course in Food Science and Quality Control as one of the choices for students seeking admission in B.Sc. The said course has been sanctioned to GDC for Women, Kathua. The syllabus of the course based on the UGC guidelines was discussed and it was resolved that necessary suggestions be forwarded to the concerned to be incorporated in the final syllabi and the syllabi and Courses of Studies in the Subject of Food Science and Quality Control for semester 1st, IInd, IIRD, IVth, Vth and VIth under the Choice Based Credit System at Undergraduate level for the examination to be held in the year mentioned below:-
