2. Class Work of 1st Semester for the Academic Session 2021-22 shall commence as and when 50% of the admissions are made by the Department/ Offsite Campuses/ Affiliated Colleges.		

IMPORTANT INSTRUCTIONS / INFORMATION FOR CANDIDATES:

- 1) Any Candidate who has not filled online admission form is not eligible for Admission. The University will not be responsible for any mistake/ lapse on the part of the Candidate while filling up of the Online Admission Form;
- 2) A Candidate who has not opted for the **Self Financing Seat/s** at the time of the filling up of the Online Admission Form along with the requisite fee will not be considered for Admission under the Self Financing Seats at any later stage;
- 3) No '**Under Process Certificate**' shall be entertained under any circumstances for Admission under any Category;
- 4) A Candidate selected for Admission under a Reserved Category has to be ready with the Original as well as the Attested Copies of the Domicile/State Subject Certificate and the other relevant Reserved Category Certificate/s as required and as issued by the Competent Authority for the purpose. Such a Candidate is required to submit the requisite Category Certificate/s to the concerned Department/s / Nodal Department/s for verification **as and when called for**. The concerned Candidates must also attach the requisite Affidavit / Certificate wherever required. The Admission of a Candidate under any Reserved Category is subject to verification / vetting / endorsement / authenticity by the Member/s of the Admission Committee of the concerned Department/ Nodal Department;
- 5) The Admission of a Candidate supplying incorrect / factually wrong information in the Online Admission Form will not be considered and is liable to be cancelled at any stage.
