Courses are taught by dedicated faculty and guest lectures are delivered by judges and advocates of repute. **Scheme & Syllabus of LL.B(3Years) Professional Course**  
**w.e.f Academic Session 2021-22**

**Course Objectives and Outcomes:**

LL.B is a full time three years Professional degree course and the degree shall be awarded to the candidates on successful completion of six semester's of study. The degree aims to harness the capacity and capability of students through Teaching, Research, Moot-Court/Mock Trials, Project Presentations/Report writing, Clinical Legal Work, Institutional visits, internship with Advocates and Judges, amongst others, so that after successful completion of the degree students develop adequate advocacy skills that will enable them to pursue a professional career at bar, competing for judicial and administrative services and absorption in the corporate sector and other allied services.

**Pedagogy:**

The Department of Law, University of Jammu imparts instruction through Lectures, Seminars, Tutorials, Moot Courts, Workshops, Class discussion and interactive sessions. The Course also includes Assignments, Court Visits, Chamber Visits, Field Visits, Institutional Visits, Research Paper Writing, Outreach Activities like Internships, Legal Aid and Legal Literacy Camps etc. to inculcate among students research aptitude, Case Law analysis and Legal Drafting skills.

**Attendance:**

The students are required to be regular to the classes and expected to have not less than 75 percent attendance.

**Award of Marks for Attendance:**

Five marks for each course, unless prescribed otherwise, shall be allotted for attendance. Break up of marks for attendance is as follows:

### **Examination:**

1. Each Course paper shall consist of 100 marks out of which 80 marks are for written examination and 20 marks are for internal assignment except for courses/Practical/Clinical Courses wherein 20 marks are kept for external Viva Voce Examination. The internal assessment of 20 marks in each paper shall be asunder:
  - a) Written Assignment for 10 Marks and Oral Presentation for 05 marks to be taken at the end of semester.
  - b) Attendance - 05Marks
2. **Assignment and Presentation:** The schedule of presentation of the assignments shall be finalized by the Head of the Department in consultation with the teacher concerned and shall be notified to the students accordingly. However, internal assessment shall be evaluated by the teacher teaching the subject. A student who fails to submit/Present the assignment on the scheduled date due to some emergency, one more chance may be given to such student for presenting the assignment, as the case may be, by the Head of the Department. Oral presentation shall be made by the students at the end of the session to the faculty concerned on a date to be fixed by the Head of the Department. After evaluation the teacher concerned shall submit the result to the Head of the department.
3. **Paper Setting Pattern:**

The question paper of each course shall be divided into two sections. **Section I** of the question paper shall be Compulsory question comprising of 4 short answer type questions (not more than 200 words each) of 4 marks each (one question from each unit) of the course. **Section II** shall comprise of 8 questions of 16 Marks each covering the entire course with internal choice in each Unit and students shall be required to attempt four questions from Section II, selecting one question from each Unit. The students shall have to attempt a total of FIVE questions. All questions carry equal marks.

#### 4. **Evaluation of Clinical Legal Courses:**

The evaluation method for each Clinical Legal Course shall be designed as follows:

- A. The examination in respect of Legal Method-I and Legal Method-II shall comprise of 100 marks out of which 80 marks shall be for internal written assignments comprising of Presentations/Assignments/Court Visits/Institutional Visits/Chamber Visits/Internships/Moot Court Memorials/Legal Aid/Legal literacy Camps/Field Study/Project Report Writing. Further, 15 marks shall be for external viva-voce and 05 marks for class attendance.
- B. The examination of **Professional Ethics** shall comprise of 100 marks out of which 80 marks shall be for written examination. Further, 15 marks shall be for external viva-voce and 05 marks for class attendance.
- C. The examination of **Drafting, Pleading and Conveyancing** shall comprise of 100 marks out of which 80 marks shall be for written examination. Further, 15 marks shall be for external viva-voce and 05 marks for class attendance.
- D. The examination of **Alternate Dispute Resolution** shall be of 100 marks out of which 80 marks shall be for written examination. Further, 15 marks shall be for external viva-voce and 05 marks for class attendance.
- E. The examination of **Moot Court Exercise and Internship (6<sup>th</sup> Semester)** shall comprise of 100 marks. The concerned Group Teachers shall assess the performance of their respective groups for 80 marks through memorials submitted and presentation given by the students. Each candidate shall prepare one civil and one criminal case on a problem assigned by the Teacher concerned and concerned teacher shall maintain a record of the evaluation of students. Further, 15 marks shall be for external viva-voce and 05 marks for class attendance.
