Adopting multi-disciplinary approaches beset with scientific, flexible and innovative methods, this professional law course is conducted by a team of highly qualified, committed and motivated faculty ensuring complete synergy of classroom lectures with practical aspects of the curriculum. Inclusion of subjects like English, Political Science, History, Sociology and Economics alongwith range of legal subjects provide an overall perspective to this professional law course. The programme also seek to harness the mooting, oratory and communication skills of students besides other personality traits / life skills through teaching, research, mootcourt/mock trials, project presentations /report writing, clinical legal work, institutional visits, internship with advocates and judges.

To enable development of professional etiquettes among students and strengthen law course, more formal means of communication viz. expert lectures, sessions by distinguished alumni and interactive sessions with legal luminaries of repute are organised by The Law School beyond the usual classroom teaching. The Law School also strives towards character building through value-based initiatives like participation in NSS activities, Bharat Scouts and Guide programs alongwith community engagement activities like legal aid, legal literacy camps enabling students to become socially responsible citizens. Thus, this flagship programme provide strong foundation to the students to pursue professional options and explore academic opportunities thereby helping them to perform much better on professional / administrative front.

In addition to 5-years BA. LL. B professional course, The Law School, University of Jammu is also running One year PG Diploma Course in Human Rights and Duties Education.

Scheme & Syllabus of B.A. LL.B (5 Years) Professional Course w.e.f Academic Session 2021-22

COURSE OBJECTIVE AND OUTCOMES:

B.A LL.B Course is of five years duration and degree shall be awarded to the candidates on successful completion of ten semesters of the Study. The degree aims to harness the capacity and capability of students through Teaching, Research, Moot-Court/Mock Trials, Project Presentations/Report writing, Clinical Legal Work, Institutional visits, internship with Advocates and Judges, amongst others, so that after successful completion of the degree, students develop adequate advocacy skills that will enable them to pursue a professional career at Bar, competing for judicial and administrative services and absorption in the corporate sector and other allied services.

PEDAGOGY

The Law School, University of Jammu imparts instruction through lectures, seminars, tutorials, workshops, class discussion and interactive sessions. The Courses also includes assignments, Court Visits, Chamber Visits and Moot Courts. Institutional Visits, Research Paper Writing, Outreach Activities like Internships, Legal Aid Legal Literacy Camps/Project Report writing/Field Study etc. to develop research, analysis and writing skills.

Attendance:

The students are required to be regular to the classes and expected to have not less than 75 percent attendance.

Award of Marks for Attendance:

Five marks for each course, unless prescribed otherwise, shall be allotted for attendance. Break up of marks for attendance is as follows:

a)	95% and above	5 Marks
b)	90 - 94%	4 Marks
c)	85 - 89 %	3 Marks
d)	80 - 84 %	2 Marks
e)	75 – 79%	1 mark

EXAMINATION:

- 1. Each Course paper shall consist of 100 marks out of which 80 marks are for written examination and 20 marks are for internal assessment except for courses/Practical/Clinical Courses wherein 20 marks are kept for external Viva Voce Examination. The internal assessment of 20 marks in each paper shall be as under:
 - a) Written Assignment for 10 Marks and Oral Presentation for 05 marks to be taken at the end of semester.
 - b) Attendance 05 Marks
- 2. **Assignment and Presentation:** The schedule of presentation of the assignments shall be finalized by the Head of the Department in consultation with the teacher concerned and shall be notified to the students accordingly. However, internal assessment shall be evaluated by the teacher teaching the subject. A student who fails to submit/Present the assignment on the scheduled date due to some emergency, one more chance may be given to such student for presenting the assignment, as the case may be, by the Head of the Department. Oral presentation shall be made by the students at the end of the session to the faculty concerned on a date to be fixed by the Head of the Department. After evaluation the teacher concerned shall submit the result to the Head of the department.

3. Paper Setting Pattern:

The question paper of each course shall be divided into two sections. Section I of the question paper shall be Compulsory question comprising of 4 short answer type questions (not more than 200 words each) of 4 marks each (one question from each unit) of the course. Section II shall comprise of 8 questions of 16 Marks each covering the entire course with internal choice in each Unit and students shall be required to attempt four questions from Section II, selecting one question from each Unit. The students shall have to attempt a total of FIVE questions. All questions carry equal marks.

4. Evaluation of Clinical Legal Courses:

The evaluation method for each clinical legal course shall be designed as follows:

- A. The examination in respect of Legal Method-I and Legal Method-II shall comprise of 100 marks each out of which 15 marks shall be for external viva-voce, 05 marks for class attendance and 80 marks shall be for internal written assignments comprising of Presentations/Assignments/CourtVisits/InstitutionalVisits/ChamberVisits/Internships/ Moot Court Memorials/Legal Aid/Legal literacy Camps/Field Study/Project Report Writing etc.
- B. The examination of **Professional Ethics** shall comprise of 100 marks out of which 80 marks shall be for written examination, 15 marks shall be for external viva voce and 05 marks for class attendance.
- C. The examination of **Drafting, Pleading and Conveyancing** shall comprise of 100 marks out of which 80 marks shall be for written examination, 15 marks shall be for external viva voce and 05 marks for class attendance.
- D. The examination of **Alternate Dispute Resolution** shall be of 100 marks out of which 80 marks shall be for written examination, 15 marks shall be for external viva voce and 05 marks for class attendance.
- E. The examination of **Moot Court Exercise and Internship** (6th Semester) shall comprise of 100 marks. The concerned Group Teachers shall assess the performance of their respective groups for 80 marks through memorials submitted and presentation given by the students. Each candidate shall prepare one civil and one criminal case on a problem assigned by the Teacher concerned and concerned teacher shall maintain a record of the evaluation of students. Remaining 15 marks shall be assessed by an external examiner through viva voce and 05 marks for class attendance.
