The applicant can download the Appeal Form from the Admission Portal www.juet.org All the requisite details are to be filled in by the applicant in his/her own handwriting. The applicant who desires to prefer an appeal will have to submit the Appeal Form(s) to the concerned Head(s) /Director(s) /Nodal Department(s) along with all the requisite / supporting documents and requisite fee receipt.

- 1. Only genuine grievance where Statutes governing admission have not been adhered to will be accepted. Incomplete and spurious appeals will not be considered.
- 2. Separate Appeal Form has to be filled in for each Course/ Programme by an applicant.
