At the outset, the Convener of the Committee welcomed the members and apprised them about the issues of deliberation and after thorough deliberations the following was resolved:

**Item No.1.** Introduction of NCC as a "General Generic Elective Credit Course" under Choice Based Credit System at the Undergraduate Level from the Academic Session 2021-2022 and to discuss the syllabi and courses of studies in the subject of NCC.

**Resolved** that the enclosed syllabi prescribed by the UGC is in line with the NEP 2020 and the courses of studies in the subject of NCC for Semester I & II (Army & Naval wings) under CBCS at Undergraduate Level from the Academic session 2021-2022 onwards may be adopted.

The BOS **resolved** that NCC subject of **24 Credits Course** be introduced as an additional Credit Course at UG Level under CBCS System from Semester I to VI as "**General Generic Elective Course**" (GGEC) in addition to the existing Credit Courses/Course Structure. The internal and external Examinations shall be conducted by the respective Colleges.

**The Course shall be offered only by the colleges having functional NCC Unit/s and extended only to the students enrolled as NCC cadets from the Academic Session 2021-2022 onwards.**
