Item No.1 To confirm the minutes of the meeting of the Standing Committee of the Academic Council held on 24.01.2017, already circulated.



RESOLVED that the minutes of the meeting of the Standing Committee of the Academic Council held on 24.01.2017, be confirmed.

Item No.2 Considered the action taken on the resolutions passed by the Standing Committee of the Academic Council held on 24.01.2017.

RESOLVED that the report of the action taken on the resolutions passed by the Standing Committee of the Academic Council held on 24.01.2017 be placed on record.

However, as far as point No.3 of the Action Taken Report is concerned, a Committee under the convenership of the Dean Research Studies with Asstt. Registrar (Adm.TW) being the Member Secretary be constituted by the Vice-Chancellor to further deliberate in the matter.

Item No.3 Considered the representations of the students of the P.G. Department of Education, University of Jammu pursuing M.A. Education (2015-17 session) for seeking permission to appear in the B.Ed. Examination as private candidates.

After threadbare discussion, it was **RESOLVED** that those candidates who were admitted in M.A. Education before June 2015 i.e. when the notification for the two Year B.Ed. Course under the NCTE guidelines in compliance to the recommendations of the Justice Verma Commission/UGC guidelines was issued, may be given one special chance to appear in the B.Ed. Examination as private candidates as per the old B.Ed. examination scheme.

Item No.4 Considered amendment in the qualification/eligibility condition for the recruitment of contractual post of Lecturer/Teaching Assistant in Geology (HSD) in the Kishtwar Campus.

RESOLVED that the proposal be routed through the DAC of the Department of Geology for approval of the same by the Vice-Chancellor and for further necessary action in the matter.

FURTHER RESOLVED that the qualification of Teaching Assistant as defined by the DAC of the Department of Geology shall be put up to the Vice-Chancellor for approval and adoption of the same.

Item No.5 Considered the matter regarding grant of Mercy Chance to the students to appear in the left over paper of Sanskrit in the 2nd Prof. Examination i.e. BAMS-2nd Prof.



RESOLVED that the grant of Mercy Chance to the students to appear in the left over paper of Sanskrit in BAMS-2nd Prof. be approved, as a one time exception.

Item No.6 Considered the matter regarding the conversion of the 50% Minority Quota Seats of the M.C. Khalsa College of Education, Jammu into open seats.

RESOLVED that the approval in the matter be sought by the College from the State Govt. for the same as per the advice of the Legal Counsel of the University of Jammu.

FURTHER RESOLVED that the two candidates belonging to the General Category who have been admitted wrongly during the Session 2017-19 under Minority Quota be regularized as a one time exception and in lieu of the same, two seats be reduced in the Open Quota of the B.Ed. Course of the College in the next Academic Session i.e. 2018-20.

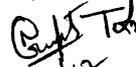
