Those having secured 55% marks or more (50% in case of SC/ST candidates) in LL.B (Professional) 3 years/5 years course are eligible to apply. The order of admission shall be as per University Statutes. The candidates shall have to appear in the Entrance Test to be conducted by the Department of Law on Friday, 22.06.2022. The Application Form, Syllabi, Modalities and Other requirements of the Entrance Test can be obtained from the office of the Department of Law or can be downloaded from the University website www.jammuuniversity.ac.in w.e.f. 23.05.2022 to 13.06.2022 @ Rs.500/- without late fee and upto 20.06.2022 with a late fee of Rs.200/- . Last date for submission of duly completed forms is 21.06.2022.

**SYLLABI, MODALITIES AND OTHER REQUIREMENTS OF THE  
ENTRANCE EXAMINATION FOR LL.M. 2 YEAR REGULAR COURSE,  
SESSION 2020-21.**

1. Subject to the eligibility requirements under the existing Statutes governing LL.M. (55% marks in qualifying degree 50% marks in case of SC & ST candidates), the eligible candidates shall apply to appear in Entrance Examination to be conducted by the Department of Law.
2. The Entrance Test shall be of three hours duration. It shall be subjective in nature and carry 100 marks. The question paper shall comprise of fifteen questions of which the candidate shall be required to attempt any ten questions (not more than 200 words per question). In order to qualify the entrance examination, the candidates shall be required to secure minimum of 50 marks.
3. The candidates who have qualified LL.B. 3 years or LL.B. 5 years from a University other than the University of Jammu should have obtained 60% marks in the qualifying examination.
4. The syllabi for the entrance examination shall be as per the syllabus prescribed for LL.B. Course and shall comprise of the following subjects:
  - i. Jurisprudence
  - ii. Constitutional Law of India.
  - iii. International Law and Human Rights
  - iv. Family Law (Hindu Law/Muslim Law)
  - v. Criminal Law (IPC/Cr PC/Evidence)
  - vi. Administrative Law
  - vii. Commercial Law (Company Law, Contract, Partnership)
5. The merit of the candidates shall be calculated on the basis of 25% weightage to the entrance test and 75% weightage to the academic merit of the candidate in the qualifying degree.
6. The entrance test shall be held on 28<sup>th</sup> June 2021 (Monday) at 10.00 a.m. in the Department of Law.
