CIRCULAR

It has come to our attention that delays in the submission of salary bills of all contractual Lecturers/Teaching Assistants engaged in various Teaching Departments/Offsite Campuses of the University of Jammu purely on temporary/contract/Academic arrangement basis for the Academic Session 2024-25, are affecting the timely disbursement of salaries. efficient processing and to avoid delays, all Rectors/Directors and HOD's are requested to submit the salary bills on the prescribed format (copy attached) for all contractual Lecturers/Teaching Assistants working under their control to the Salary Wing Section strictly between 25th to 27th of every month so as to ensure that salary bills are processed, uploaded and sent to the Treasury in a timely manner. Adherence to these deadlines will facilitate the prompt disbursement of salaries to all contractual teachers, avoiding any inconvenience caused by delayed payments.

This is in supersession of the circular issued earlier vide No.Accounts/Salary/2023/3429-78 dated 22.11.2023.
