## CIRCULAR

It is hereby ordered that for the Academic Session 2026-27, the HODs/Rectors/Directors/Coordinators/Principals may engage the eligible Teaching Faculty in their respective Departments/Campuses/Directorates/Institutes/Centres on lecture-basis (eligibility as per UGC Regulations- 2018) until fresh selections on purely temporary and need basis for the Academic Session 2026-27, are made.

However, such arrangement shall be made only in respect of the Departments/Campuses/Directorate/ Institute, where at least five (05) students have been admitted or are studying in a course.

The honorarium on this account shall be debited to the Local Fund/Consolidated Local Fund of the respective Department/Campus/Directorate/Institute/Centre (whichever is applicable) in terms of University Order No. Adm/TW/C&R/24/655-700 dated 02.08.2024 (copy enclosed).

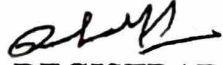

## ORDER

In continuation to order No: Adm/TW/C&R/24/613-50 dated 30.07.2024 and on the recommendations of the Committee constituted to consider the matter regarding honorarium being paid to the contractual faculty engaged on lecture basis, the Vice-Chancellor in anticipation of the approval of the competent bodies, is pleased to revise the rates of honorarium of contractual faculty engaged on lecture basis from Rs. 500/- per lecture to **Rs.600/- per lecture** (maximum of two lectures in a day including conveyance allowance) subject to a maximum of **Rs.25000/- per month** instead of Rs. 20000/- per month w.e.f. **01.08.2024**.

The above rates are being revised in terms of the "guideline for engagement of faculty on Academic arrangement/Guest Faculty in Government Degree Colleges/GCET etc. of UT of Jammu and Kashmir" issued by the Higher Education, Govt. of J&K vide order No.137-JK(HE) of 2024 dated 01.03.2024.
