## Agenda and Resolutions

### **Item-I: Confirmation of Previous Minutes**

**Agenda:** To confirm the minutes of the BOS meeting held on **01.08.2025**, already circulated.

**Resolved:** The minutes of the BOS meeting held on **01.08.2025** were confirmed unanimously.

### **Item-II: Framing of Syllabi for B.P.E.S. (Semester I to IV)**

**Agenda:** To formulate the syllabi and courses of study for the **Bachelor of Physical Education and Sports (B.P.E.S.)** for the **Four-Year Undergraduate Programme (FYUGP)** as per **NEP-2020** to be implemented from the **Academic Session 2025-26** onwards.

- **Semester I: December 2025, 2026, 2027 & 2028**
- **Semester II: May 2026, 2027, 2028 & 2029**

**Resolved:** The Board deliberated upon the proposed structure and scheme of things of the entire course whereas the course scheme of **B.P.E.S. Semesters I to IV** was framed, also the entire course content of Semester I & II has been finalized and approved the same in principle as per the **NEP-2020** framework. The Convener was authorized to incorporate necessary modifications, if any, suggested by members and finalize the syllabi for onward submission to the Faculty of Education and subsequent statutory bodies of the University.

### **Item-III: Preparation of Panel of Paper Setters/Examiners**

**Agenda:** To prepare a panel of paper setters and examiners to be submitted to the Controller of Examinations, University of Jammu.

**Resolved:** The Convener was authorized to prepare and submit the panel of paper setters and examiners for the **FYUGP** course to the Controller of Examinations. As both **B.P.Ed** and **B.P.E.S.** courses now follow **NEP-2020**, the panel for Physical Education shall remain within the Department.

### **Item-IV: Any Other Item with Permission of the Chair**

**Agenda:**

1. **To discuss the proposal for organizing a Camp for Semester-III students, a State Tour for Semester-V students, and a National Tour for Semester-VII students.**

**Resolved:** The Board discussed the proposal in detail and resolved that the Camp, State Tour, and National Tour shall be organized as part of the experiential learning component of the **B.P.E.S.** programme. A committee will be constituted to plan, coordinate, and execute these activities as per university norms and available resources. The finalized schedule and budget will be submitted for approval to the competent authority.


2. **Eligibility Criteria for admission in B.P.E.S Course.**

**Resolved:** The Board deliberated upon the eligibility criteria for admission in B.P.E.S course, it was resolved that the eligibility criteria prescribed by the University of Jammu for all other Undergraduate Programmes shall be adopted and taken into consideration while admitting students to the Bachelor of Physical Education and Sports (B.P.E.S.) Course.

3. **Scheme of Examination for B.P.E.S Course**

**Resolved:** The Board reviewed and discussed the scheme of examination for the Undergraduate Programmes in Physical Education and Sports. It was resolved that the scheme of examination shall remain in accordance with the existing statutes and regulations of the University of Jammu governing Undergraduate Courses.
