Resolution: All members of BoS unanimously confirmed the minutes of the meeting of BoS in Electronics held on 06.11.2023 and 07.11.2023.

Item No. 2: To formulate the syllabi and courses of Studies of Master Degree Programme in Electronics as per Course Framework of One/Two Year Postgraduate Programmes under National Education Policy (NEP2020) for Academic Session 2025 onwards.

Resolution: The convener apprised the members of BoS regarding the formulation of syllabi and courses of Studies of Master Degree Programme in Electronics as per Course Framework of One/Two Year Postgraduate Programmes under National Education Policy (NEP2020) for Academic Session 2025 onwards and requested the members to frame courses as per NEP 2020. After threadbare discussion, the members of BoS recommended the framed syllabi of both one year and two-year PG programmes in Electronics based on NEP 2020 with required credits as per template provided (enclosed as Appendix-A & B) for final approval of the Competent Authority. It was also resolved to keep 04 theory papers each of 04 credits with enhanced lab work of 06 credits (instead of 04 credits) and a seminar of 02 credits in lieu of fifth theory paper in semester-1 and semester-3 of one year and two-year PG programmes in Electronics respectively, meeting the required credits.

Item No. 3: To review the syllabi and courses of studies of Master Degree Programme in Electronics of semesters I to IV under Choice Based Credit System for Repappar Candidates for the academic session 2025-2026 onwards.

Resolution: All members of BoS agreed to extend the validity of syllabi and courses of Master Degree Programme in Electronics of semesters I to IV under Choice Based Credit System for Repappar Candidates for the academic session 2025-2026 onwards.

Item No. 4: To review the syllabi and courses of studies in the subject of Electronics of Semesters I to III of Four Year Under Graduate Programme (FYUGP) as per NEP 2020.

Resolution: The members of BoS reviewed the syllabi and courses of studies in the subject of Electronics of Semesters I to III of Four Year Under Graduate Programme (FYUGP) as per NEP 2020. After threadbare discussion, the members of BoS recommended the reviewed syllabi of Semesters I to III of FYUGP as per NEP 2020 for final approval of the Competent Authority (enclosed as Appendix-C).

Item No. 5: To review the syllabi and courses of studies in the subject of Electronics of Semesters I to III of Four Year Under Graduate Programme (FYUGP) as per NEP 2020 for Re-appear Candidates examinations to be held in the years from December 2025 to December 2028.

Resolution: The members of BoS reviewed the syllabi and courses of studies in the subject of Electronics of Semesters I to III of Four Year Under Graduate Programme (FYUGP) as per NEP 2020 for Re-appear Candidates examinations to be held in the years from December 2025 to December 2028.

Item No. 6: To formulate the syllabi for five-year Integrated Programme in Electronics.

Resolution: The convener apprised the members of BoS regarding the formulation of syllabi for five year Integrated Programme in Electronics which is to be started by the Department of Electronics. After thorough discussion it has been observed that commencement of five-year Integrated Programme in Electronics under NEP 2020 needs Minor/Multidisciplinary/Skill enhancement courses etc which are to be taken from other Departments. Since there has been no formulation of such courses in other Departments on the pattern of Design Your Degree, as such it has been unanimously resolved to defer the formulation of syllabi for five-year Integrated Programme in Electronics till formal notification regarding creation of Minor/Multidisciplinary/Skill enhancement courses etc by other Departments is issued by the University under the purview of NEP 2020.
