






1. Three sets of xerox copies of all documents (10th to LL.M including category and domicile, where-ever applicable).

6. Degree of Graduation/LLB/BALLB etc
7. Two passport size photographs.
8. Affidavit duly sworn before a First-Class Judicial magistrate with the averment stating that the candidate is not practicing in court of Law as advocate/serving in any Govt. /Private Job or has not joined any other institution or programme of study and shall not join any other institution or any govt./Pvt. Job without intimating the department during his/her course work.
9. General Affidavit applicable for admission in University of Jammu.


