Admission to the Ph.D. programme shall be made strictly on the basis of composite merit, comprising the following:

- Entrance Test: 70% weightage
- Interview: 30% weightage

Candidates are advised to note that mere qualifying in the entrance/ interview does not entitle a candidate to admission to the Ph.D. programme. Admission shall be done solely on the basis of the final composite merit determined as per the above criteria and subject to the availability of seats and fulfillment of all applicable admission requirements. All candidates are further directed to produce all original certificates, documents, and testimonials required for Ph.D. admission before the DRC at the time of interview and document verification as per the schedule mentioned above. Candidates failing to appear for the interview or failing to produce the required original documents may not be considered for admission.
