STATUTES FOR THE DEGREE OF BACHELOR OF LAWS TWO YEARS, THREE YEARS AND FIVE YEARS COURSES

- There shall be the following courses of study in the University:-
 - (A) Bachelor of Law (three Years) LL.B. (Professional)
 - (B) Bachelor of Arts and Law (Five years) B.A., LL.B.

The course for the degree of Bachelor of Laws (Three Years) Shall extend over a period of three academic years and the course for Bachelor of arts and Law (Five Years) shall extend over a period five academic years. Each academic year shall be divided into two semesters.

- There shall be two examinations in an academic year, at the end of each semester respectively.
- The examination shall be held in accordance with the syllabi approved by the Academic Council.
- 4. The Academic Council may, on the recommendations of the Faculty of Law, make such changes in the courses of study prescribed in the Statutes as may be considered necessary from time to time.
- 5. English shall be the medium of instruction and examination.
- 6. One paper carrying 80 marks shall be set for each course of study prescribed for a Semester. There shall be written examination of three hours duration in each paper. However, the Practical Training Courses shall be conducted as per the syllabus and the regulations separately framed in this regard.
- 7. The examination shall be open to:-
- a) A regular student who produces the following certificates signed by the Head of the Department of Law/ The Director, Law School/Principal of the affiliated college or any other teacher of the Department/affiliated College authorized by the Head of the Department of Law/ The

STATUTES GOVERNING THE DEGREE OF BACHELOR OF LAW (THREE YEARS) AND BACHELOR OF ARTS AND LAW (FIVE YEARS)

- 1. There shall be the following courses of study in the University:-
 - (A) Bachelor of Law (three Years) LL.B. (Professional)
 - (B) Bachelor of Arts and Law (Five years) B.A. LL.B.

The course for the degree of Bachelor of Laws (Three Years) shall extend over a period of three academic years and the course for Bachelor of Arts and Law (Five Years) shall extend over a period of five academic years. Each academic year shall be divided into two semesters.

- 2. There shall be two examinations in an academic year, at the end of each semester respectively.
- The examination shall be held in accordance with the syllabi approved by the Academic Council.
- 4. The Academic Council may, on the recommendations of the Faculty of Law, make such changes in the courses of study prescribed in the Statutes as may be considered necessary from time to time.

- 14. The remuneration for setting a question paper and for evaluating an answer-book shall be as prescribed by the University from time to time.
- 15. No formal certificate of LL.B (3 years having passed the first Second, Third, fourth and fifth Semesters examinations shall be issued to any candidate. However, a statement of marks obtained in each semester examination shall be supplied to every candidate.
