

Rescue team yet to contact workers trapped in tunnel

Personnel reach up to 150 metres from the spot of accident in Nagarkurnool district of Telangana, but debris, mud are hindering further progress; more than a day has passed since the cave-in

escue teams could achieve a breakthrough till late on Sunday evening in tracking eight persons trapped for over 30 hours in an under-construction tunnel in Nagarkurnool district of Telangana.

Two engineers, technical staffers and four have workers been trapped 14 km inside the tunnel of the Srisailam Left Bank Canal Project since Saturday morning, after a portion of its roof collapsed during excavation a tunnel-boring machine.

After a day-long effort, rescuers said they were 150 metres from the accident site, with mud and debris hindering progress. The joint rescue operation was

taken up by National Disaster Response Force, Army, Singareni Collieries, State Disaster Response Force and NHIDCL personnel. "The situation inside is very scary with muck and other debris covering almost the entire tunnel," said State Minister for Excise and Tourism Jupally Krishna Rao, who supervised the rescue operation from deep inside the tunnel for several hours on Sunday. The debris had co-

vered the entire 23-foothigh, 31-foot-wide tunnel, he said.

Trump attacks USAID again over 'India grant' amid doubts over DOGE charge

U.S. President Donald Trump took another swipe on Sunday at the U.S. Agency for International Development (USAID) and India for an alleged grant of millions for "voter turnout" during Indian elections.

Since the Department of Government Efficiency (DOGE) headed by tech billionaire Elon Musk spoke of the grant on February 16, Mr. Trump has referred to it on five occasions at various public events, but more and more questions are being raised on the veracity of the information.

"Eighteen million dollars for helping India with its elections. Why the hell?" Mr. Trump said at the Conservative Political Action Conference on Sunday.

As he reeled off the number of grants allocated by the USAID according to the DOGE list, which in-

CDU's Merz set to be next Chancellor of Germany

Germany's conservatives won Sunday's elections, with their leader Friedrich Merz set to become the next Chancellor, followed by the far-right AfD in second place after record gains, according to exit polls. If confirmed in the final count, the Alternative for Germany (AfD) roughly doubled its score to at least 19.5%, boosted by fears over immigration and security after a spate of attacks

blamed on asylum seekers. Mr. Merz's CDU/CSU alliance won at least 28.5%, said the first exit polls from two public broadcasters, crushing the centre-left Social Democrats (SPD) of the outgoing Chancellor, Olaf

Scholz, which were looking at around 16%.

Mr. Merz – a long-time party rival of ex-chancellor Angela Merkel – has vowed a crackdown on irregular immigration. He hopes to win back votes from the AfD and halt its rise, which has stunned many in a country still seeking to

atone for its Nazi history. For now, the AfD – basking in the vocal support of key allies of U.S. President Donald Trump – is set to stay in Opposition.

Before Mr. Merz, 69, takes over from the now caretaker chancellor Scholz, he will have to forge a new coalition government in Europe's top economy, an often drawnout process he has vowed to complete by Easter.

Atishi elected LoP in Delhi, says will hold BJP to all its promises

The Aam Aadmi Party (AAP) on Sunday unanimously elected former Delhi Chief Minister and MLA Atishi as the Leader of the Opposition in the Assembly. At an AAP legislature group meeting, Ms. Atishi's name was proposed by Sanjeev Jha, MLA-elect, with Kuldeep Kumar and Jarnail Singh backing the nomination. This will be the first time AAP will be in the Opposition since coming to power in 2013.

AAP national convener Arvind Kejriwal met all MLAs-elect and congratulated Ms. Atishi for being chosen as the leader of the legislature party. "AAP will play the role of a construc-



tive Opposition in the inter-

est of the people," he said. Ms. Atishi said AAP accepted the responsibility of serving in the Opposition with full commitment. "A strong Opposition plays a crucial role in a democracy, and AAP will ensure that the voices of the people are effectively raised in the Assembly. The BJP made several promises to

the people of Delhi, based

on which they received the

public mandate. As the Opposition, it is our duty to ensure that these promises are fulfilled," she said.

Ms. Atishi noted that one of BJP's significant promises was made by Prime Minister Narendra Modi himself - a guarantee to approve in the very first Cabinet meeting a scheme to provide ₹2,500 per month to every woman in Delhi, with the first instalment to be credited by March 8.

"However, the first Cabinet meeting has already taken place, and this scheme was not approved. As the Opposition, it is our responsibility to hold the BJP accountable," she said.

Aam Aadmi Party (AAP) leader Atishi on Sunday said 12,000 contractual workers of the Municipal Corporation of Delhi (MCD) will be regularised at a meeting of the House on February 25.

The former Chief Minister said her party is committed to regularising temporary workers in the AAP-led MCD.

"In the last two years, we have made 4,500 (contractual) workers permanent. As many as 12,000 more will be regularised. This will be the biggest decision in the MCD's history, where such a large number of employees will be made permanent in a single decision," Ms. Atishi added.

However, the Leader of Opposition in the MCD House, Raja Iqbal Singh, said "Ms. Atishi is well aware that the approval of the Municipal Commissioner and the Finance Department is mandatory. No such approval had been sought until February 23. This entire matter is a farce."

First session of new **Delhi Assembly today**

New BJP govt. is set to table 14 pending CAG reports in the House during the three-day session; BJP making unnecessary hue and cry, says Atishi

Tewly elected members of the eighth Legislative Assembly of Delhi will take oath on Monday when Chief Minister Rekha Gupta is scheduled to move a motion to name BJP MLA-elect Vijender Gupta the Speaker of the House.

The list of business for the three-day session shows that the 14 pending Comptroller and Auditor-General (CAG) reports on the performance of the erstwhile AAP government will be tabled in the House on the second day.

After her first Cabinet meeting on February 20, the day she was sworn in, Ms. Gupta said her government would table the 14 CAG reports in the Assembly's first session. The BIP has been alleging that AAP had not tabled the reports as they contained "proof of corruption".

Responding to the development, former Chief Minister and senior AAP lead-

er Atishi said "the BJP's only motive is to score political points". Ms. Atishi claimed that as CM, she had personally signed the CAG reports and submitted them to the Speaker of the previous Assembly. "It is a routine procedure. The BJP is making it a big deal by showing that they have presented the CAG reports. Whatever is there in the reports, it will be out in front of the people of Delhi," she added.

Lieutenant-Governor V.K. Saxena has appointed BJP MLA-elect Arvinder Singh Lovely as the pro tem Speaker. The members of the House will take oath before the pro tem

According to the list of businesses, the L-G will address the House on the second day of the three-day session, and the CAG reports will be tabled. This will be followed by a motion of thanks, which will continue on the third day, February 27. The election of the Deputy Speaker will be held the same day.

AAP left 'public exchequer empty': CM; Atishi hits back

Delhi Chief Minister Rekha Gupta on Sunday alleged that the previous AAP government had left the "public exchequer empty", prompting her predecessor Atishi to hit back claiming that it was an "excuse" by the BJP to not deliver on its election promises.

Ms. Gupta said she held meetings with officers over the implementation of the Mahila Samriddhi Yojana, the scheme that promises ₹2,500 per month to women beneficiaries in Delhi.

"When we sat with the officials to review the financial status, the public exchequer was found completely empty," Ms. Gupta said while addressing mediapersons ahead of the first session of the newly constituted 8th Delhi Assembly. However, she gave assurance that the scheme will be implemented after proper planning.

Responding to the Chief Minister's allegation, Ms. Atishi said the BJP was using the "financial crisis" as an excuse to not deliver on its promises. She said the BJP had promised to clear

the scheme in the first Cabinet meeting, but had failed to do so. "The women had put their trust in Modiji's guarantee, but now they feel deceived," the AAP MLA-elect said.

Delhi's budget has grown from ₹31,000 crore in 2014-15 to ₹77,000 crore in 2024-25 under AAP and "we handed over a fiscallystrong Delhi to the BJP", she said. "I challenge the BJP to show any State where it is in power that has seen economic growth like Delhi," Ms. Atishi said.

Earlier, BJP general secretary Pavan Rana briefed the BJP MLAs-elect on conduct in the House. Ms. Gupta also met the MLAselect, many of them firsttime members like her. They were given dos and don'ts in the House.

'Faith in decision'

Meanwhile, Union Home Minister Amit Shah on social media expressed his trust in the BJP's decision to choose Ms. Gupta as the CM. "Keeping the trust that the people of Delhi have shown in the leadership and public welfare policies of Prime Minister Narendra Modi intact, your tenure as Chief Minister will definitely take Delhi to new heights and fulfil all the hopes and aspirations of the people," Mr. Shah said in a post on X.

Arvey, a student of a private school in Farida-

"The school principal, academic coordinator and three male students were named in the FIR. They all got bail in a single day and there has been no justice even after three years," Ms. Malhotra said.

She said her fight is not just for her son but for all children who are being harassed in their schools for not "fitting in".

DMK functionary, four others deface Hindi signage; booked

The Railway Protection Force (RPF) on Sunday booked a DMK functionary and four others for defacing the Hindi words on the signage at Tamil Nadu's Pollachi Junction railway station. The RPF registered a case against 'Thendral' Selvaraj, who is in-charge of DMK's legal wing for Coimbatore south, and four others. A case has been registered against the accused for offences committed under Sections 166 (defacing public notices), 147 (trespass and refusal to desist from trespass), and 145 (b) (commits any nuisance or act of indecency or uses abusive or obscene language) of the Railways Act, 1989.

Assam: USTM chancellor sent to 14 days' judicial custody

The chancellor of the University of Science and Technology, Meghalaya (USTM), Mahbabul Haque, arrested on charges of promising students to allow unfair means in exams, has been remanded in judicial custody by a local court in Assam's Sribhumi district. Mr. Haque, along with five teachers of a school in the district, were sent to 14 days' custody after a late-night hearing by the court on Saturday, an advocate involved in the case said. Commenting on the arrest, Assam CM Himanta Biswa Sarma said he was aware of a "large network", which promises students high marks through unfair means. PTI

Karnataka-Maharashtra border remains tense as language row escalates

One more held over assault of Karnataka bus conductor; State Transport Minister to visit Belagavi today; bus services to Maharashtra expected to resume soon if no exacerbation of tension: officials

The Hindu Bureau BELAGAVI

arnataka Transport Minister Ramalinga will visit Belagavi on Monday amid the tense situation on both sides of the Karnataka-Maharashtra border following the assault on a North Western Karnataka Road Transport Corporation (NWKRTC) bus conductor on Friday after he asked a passenger to speak in Kannada.

Bus services across the boundary have been suspended by both States as part of safety measures soon after the assault.

Mr. Reddy's planned visit has triggered hopes that bus services may resume on Monday from the Karnataka side. Karnataka transport officials have indicated that the services are expected to resume on Monday if there is no more escalation of tension.

Mr. Reddy stressed the need for taking action against those who attacked

the conductor and damaged KSRTC buses. He said defacing buses in both States served no purpose and would only escalate tension. He also called for the various linguistic communities to live peacefully.

Meanwhile, the Belagavi police have arrested one more person accused of assaulting the conductor. With the arrest of Mohan Hanchinal of Chikka Balekundri village, the number

of those arrested has risen to five, including a minor.

The injured conductor, Mahadevappa Hukkeri, is undergoing treatment in Belagavi.

On Saturday, a countercase had been filed under provisions of the Protection of Children from Sexual Offences (POCSO) Act against the conductor by some villagers of Chikka Balekundri, alleging that he was trying to molest a minor girl on the bus.

Karnataka Rakshana Vedike president Narayana Gowda will be visiting Belagavi on Tuesday to condemn the attack on the conductor.

Retaliatory attacks

Bus services between Karnataka and Maharashtra were stopped after some activists of the Shiv Sena (UBT) allegedly damaged KSRTC vehicles in Pune and Kolhapur. Karnataka Rakshana Vedike activists had stopped some Maharashtra buses in Athani and Ramdurg in Belagavi.

As of now, buses are plying only up to the inter-State boundary. According to officials, NWKRTC buses may start inter-State operations on Monday.

Maharashtra Transport Minister Pratap Sarnaik had said on Saturday that Maharashtra State Road Transport Corporation (MSRTC) buses will not operate till talks are held between the Ministers concerned of both States.

Rajasthan Minister defends comment amid Cong. backlash

Amid protests by Congress MLAs in the Rajasthan Assembly over his remark on former Prime Minister Indira Gandhi, Minister of Social Justice and Empowerment Avinash Gehlot has defended his statement, saying the word he used for her was not insulting.

During Question Hour on Friday, Mr. Gehlot pointed towards the Opposition and said, "Like always, you named the scheme [on working women's hostels] after your daadi Indira Gandhi in the 2023-24 budget." The remark caused an uproar in the House, and led to three adjournments and the suspension of six Congress MLAs, including State Congress chief Govind Singh Dotasra, Ramkesh Meena, Amin Kagzi, Jakir Hussain, Hakam Ali, and Sanjay Kumar.

"Indira Gandhi was a respected Prime Minister of our country. I only used the word *daadi* (grandmother) for her, which is not inappropriate in any context," Mr. Gehlot said during a visit to Ihunihunu on Sunday.

Demanding an apology from the Minister and revocation of the suspension of

The Opposition parties will try to corner the ruling Aam Aadmi Party (AAP) on a host of issues, including law and order, rising State debt, deportation of illegal Indian immigrants, and the plight of farmers, in the two-day session of the Punjab Assembly commencing on Monday.

Shiromani leader Daljit Singh Cheema said many issues will be raised in the session by the

party MLAs. "Besides, farmers' plight, illegal sand mining, unemployment, drugs, and higher fiscal deficit will be taken up in the session," said Mr. Cheema.

The issue of illegal travel agents will also be taken up, he added.

The Punjab Vidhan Sabha session will start with obituary references on February 24.

Haryana municipal elections low-key affair for JJP, AAP, INLD

Less than six months after a closely fought Assembly poll, the Congress and the ruling BJP are gearing up for yet another contest in Haryana with the election to 33 municipal bodies, including eight municipal corporations, slated for March 2. More than 600

wards are up for grabs. However, the two regional parties led by the Chautalas – Jannavak Janta Party (JJP) and Indian National Lok Dal (INLD) – and the Aam Aadmi Party (AAP), which contested 89 out of the 90 seats in the Assembly poll, remain largely indifferent towards the polls and are contesting fewer seats this time.

'In revamp mode'

The Dushyant Chautala-led JJP had joined hands with the BJP to contest the elections to 46 municipal bodies in June 2022 and won the president's post in ty has fielded only two candidates for the municipal polls this time. "The party is in restructuring mode after the Assembly poll and dissolved all its units in December last year. Only after all district units are reconstituted would the party consider contesting any poll. As two of our leaders were keen on contesting, the party allowed them to fight on its symbol," said JIP spokesperson Deepkamal Saharan.

A JJP leader on condimonymity said the party did not have a significant support base in urban areas and that was one of the reasons to stay away from the municipal polls.

Struggling to find a foothold in Haryana politics for more than a decade, AAP faces internal strife now. A faction is staying away from the polls and seeking an overhaul in the wake of the party's dismal show in the Assembly poll.

AAP had registered its first electoral victory in Haryana by winning the president's post in the Ismailabad municipal committee in 2022 and got about 10% of the votes in the State. However, the party has fielded only three mayoral and six presidential candidates this time, besides around 50 candidates for various municipal wards.

Traditionally not keen

on contesting municipal elections, the INLD, with its mostly rural vote bank, has only fielded a mayoral candidate in Rohtak, a candidate for the president's post in Sirsa, and candidates in three wards in Ambala Cantonment. Party

spokesperson Rakesh Sihag said the decision to contest the polls was left to the district units, and candidates were fielded in consultation with them.

Station stampede: as life chugs back to normalcy, kin of victims struggle to find answers

Forty-eight hours is a long time to get on with life, especially at the New Delhi Railway Station. On February 17, nearly 48 hours after the stampede that killed 18 people, 52-yearold Rajesh Upadhyay was in a hurry to board a train to Prayagraj, Uttar Pradesh. While platform no. 16 remained crowded, with few signs of the chaos that had transpired two days before, Upadhyay was confident that his good karma would see him through the journey. "I have committed no paap (sin), so I believe I'll not face any badha (hindrance)," he said, hopping on to an AC 3-tier compartment of the Magadh Express along with

his wife and son. As people continue to head to Prayagraj for the Maha Kumbh, the crowd surge at the railway station has left officials on the ground baffled. If anything, people are in a hurry since the religious fair is coming to an end on February 26, said a railway official.

According to his colleagues, even on February 16, a day after the stampede, 18.48 lakh passengers were ferried to the Maha Kumbh in 388 trains from various States. Till 6

p.m. on February 17, more than 14 lakh passengers were transported in 266 trains. "The Kumbh rush will continue till February 26," officials told The

Upadhyay believes one needs to be fortunate enough to be able to make the trip and take a dip in the "sacred waters" of the Triveni Sangam. "I believe my fate will take me to Prayagraj safely."

Boarding the general compartment of the Shiv Ganga Express, Rakhi Shaw, 27, and her husband Rajat Shaw, 28, didn't want to back out at the last minute. "Both of us have appeared for government job exams and are awaiting the results. We feel if we take this holy journey together, maybe we can get through this hurdle," she said.

Of fate and faith

Mira Devi, a 45-year-old resident of Kanjhawala in Delhi, said attending this year's Kumbh was extremely important for her. "My three children are unemployed. If taking a dip in the Sangam can rid me of my sins and help my children, I'll take a chance," she said, adding that she said her prayers before setting out for the station.

Employment was a big reason why Prabhu Shaw, a resident of Motihari in Bihar, also sent his 18-yearold daughter Baby Kumari

to live with her uncle's family in Delhi. Kumari was headed to Prayagraj along with her uncle, aunt, and cousin when they were caught in the stampede. While Kumari died, her cousin Khushi and aunt Sharda Devi were injured in the incident.

"My parents, Baby didi, and I were travelling together from Delhi, while our relatives from Bihar were supposed to meet us at the Prayagraj station," recalled Khushi.

While all three left their rented accommodation in Delhi's Bijwasan on February 15 together, by the end of the night, Kumari's body, wrapped in white sheets, was sent to her village in Bihar along with ₹10 lakh in cash and police protection.

Prabhu doesn't want to blame anyone and claimed it's God who snatched his daughter away. "Punya kamane ja rahi thi, par kismat ko manjoor nahin tha (She was going to receive blessings, but was not destined for it)," he said, adding that he had sent his child to Delhi to pursue higher education so she could secure a job.

However, her blames the railway officials and the government. "If you know that the trains are packed, then why sell more tickets?" a visibly angry Sharda said. Mohit Malik, husband of

18 killed in the stampede, also feels the railway officials were at fault. "Why boast that you have provided special trains when there is no space for people to even stand inside them? Why continue to sell tickets when you can clearly see that the stations are overcrowded?"

Talking about the instant ex gratia payment to the families of the deceased and the injured in cash, he wondered if the money could bring his wife back to life. "Then what good is it for? Is this the price of a life, or to buy people's silence?"

Hours after the stampede, the Railways, in a statement, said it paid ex gratia of ₹10 lakh to the kin of the 18 deceased. It distributed ₹2.5 lakh to the grievously hurt and ₹1 lakh to those with minor injuries among the 15 injured.

According to a 2023 guideline of the Railway Ministry on ex gratia relief, up to "₹50,000 [is] to be paid in cash as immediate relief". The rest of the money has to be paid by "account payee cheque/RTGS/ NEFT/any other payment mode".

Officials clarified that the ex gratia for the February 15 incident was given in cash because of "extraordinary circumstances".

they said, is "routine and applies to normal incidents". The February 15 incident was an extraordinary situation. Even in earlier incidents, cash had been distributed as it became cumbersome and time-consuming to gather bank account details, while cash could be used instantly during the crisis, they added.

The Railways distributed nearly ₹2 crore in cash as compensation following the stampede to victims and their families. "How does all that mat-

ter," said Opil Singh, 32, a resident of Delhi's West Sagarpur. Just after losing his seven-year-old daughter, Singh found himself standing in front of TV cameras at Lady Hardinge hospital as eager reporters thrust their microphones in his face. As he opened his mouth to speak, a policeman warned him, "Bas tumhare gharwalon mei kaun kaun ghayal huya aur tum wahan kya kar rahe the yeh bolna hai, baki zvada bolte rahoge toh muavza nahin milega (Just say whatever transpired that night and who all were hurt in your family. You may just lose the compensation coming your way if you talk too much)."

More than a week after the tragedy, the usual commotion at the New Delhi Railway Station belies any signs of a tragedy.

While railway staff worked through the night following the stampede to clear the haunting remains - shoes, bags, clothes, and strewn food – a pile of unclaimed belongings lay stacked in a corner of a room in the police post near platform no. 16.

An officer is in charge of taking photographs of the people who come to claim their goods, and then post them on the police WhatsApp group to ensure that "they don't claim what is not theirs". If the items continue to lie unclaimed, they will be sent to the 'Lost & Found' section, said a railway official.

No telltale signs

Forty-year-old Hasib, a porter who was present at the station on the night of the stampede, said it's difficult to trace the telltale signs of the tragedy at the site now. "Just like the man who kept looking for his wife for two days," Hashib said, referring to Gupteshwar Yadav, 50, a resident of Shadipur Depot, Delhi, whose wife, Tara Devi, got separated from him in the stampede. "No one knows if he found her. No one cares any longer I guess," he said.

Two booked for 'attempt to sabotage train' in Kerala

The Hindu Bureau KOLLAM

Two persons detained on Saturday for allegedly placing a telephone pole across a railway track at Kundara in Kerala have been charged under Section 327 (1) of the Bharatiya Nyaya Sanhita and Sections 150 (1) (a) and 153 of the Railway Act.

The accused were brought to the incident site on Sunday for collecting evidence. They had earlier testified that the post was placed on the track so that a train could break the cast iron part of the post, which could then be sold.

The police suspect a different motive as the post was placed in two places. They said a detailed investigation would follow.

There were allegations that the accused had tried to derail the Palaruvi Express. One of the accused is involved in around 11 criminal cases while the other is involved in five cases, including an attack on a former Kundara SI, a senior police officer said.

When asked whether the duo was questioned by the National Investigation Agency (NIA), the police officers said multiple national agencies interrogated

Railway authorities had removed the obstruction early Saturday morning after a resident spotted the telephone post around 1.30 a.m. and alerted them. CCTV footage from the scene led to the arrest of the duo.

Rescue efforts on in full swing: Telangana Minister

Dewatering operation is on and oxygen being pumped into tunnel, says N. Uttam Kumar Reddy; steps being taken to prevent waterlogging; govt. looking into possibility of other methods, he adds

he Telangana government is making all-out efforts to rescue the eight workers trapped inside the collapsed portion of the Srisailam Left Bank Canal (SLBC) project tunnel in Nagarkurnool district.

The joint rescue teams leading the efforts comprise the Army, the NDRF, the SDRF, Singareni Collieries, NHIDCL personnel and experts who handled the Silkyara tunnel collapse in Uttarakhand.

Minister for Irrigation N. Uttam Kumar Reddy said that as part of the efforts to ensure a swift and safe rescue of those trapped inside, dewatering operation was going on and oxygen

(fresh air) was being continuously pumped into the tunnel.

"Chief Minister A. Revanth Reddy is personally monitoring the situation and the entire administration is on a high alert," Mr. Reddy said after returning

to Hyderabad from the accident Domalapenta.

He said Prime Minister Narendra Modi spoke to the Telangana Chief Minister on Saturday, assuring him of providing all necessary assistance. Leader of

the Opposition Rahul Gandhi also expressed support for the rescue efforts.

The situation at the accident site is critical and the intense seepage of water and muck deposit on the tunnel floor after collapse of a portion of it is seriously hampering the rescue operation, the Minister said. Steps are being taken to prevent waterlogging and the government is also exploring the possibility of employing alternative methods not only to clear the mud inside but also to bring out those trapped safely.

He added that taking heavy machinery into the tunnel was difficult due to the terrain, but officials were working on alternate methods to remove the de-

Cong. brass irked as Tharoor says party leaderless in Kerala

Congress Working Committee member Shashi Tharoor, MP, seemingly struck a discordant note within the party by reportedly speaking of the "absence of a leader in Kerala's Congress", meaning the party is leaderless in the State.

Mr. Tharoor's "averment" in an interview in a newspaper published from New Delhi on Sunday appeared to ruffle feathers in the Congress leadership in the State. Kerala Pradesh Congress Committee president K. Sudhakaran told presspersons in Thrissur that Mr. Tharoor had crossed a line.

Mr. Tharoor had yet to deny the statement, which



stirred controversy less than a week after he earned the Congress's ire for praising the Left Democratic Front (LDF) government for its work in the start-up sector and ease of doing business in the State.

That controversy had culminated in a private meeting with Congress leader Rahul Gandhi in New Delhi. Congress leader Ramesh Chennithala hinted that Mr. Tharoor's

interview was likely politically superfluous as it was given before the meeting with Mr. Gandhi.

Mr. Tharoor appeared to advocate for his candidacy as the party's leader ahead of the 2026 Assembly election. In the interview, he said opinion polls from independent agencies indicated he was "ahead of others in leadership stakes in [the Congress] in Kerala".

In the interview, Mr. Tharoor said non-partisan political support had catalysed his four consecutive wins from the Thiruvananthapuram Lok Sabha constituency. The Congress should expand its base among non-Congress voters as he had done. "That is what we want in 2026."

South's top cybercrime officials to meet in Hyderabad in March

Hyderabad is gearing up to host a high-level cybercrime meeting in March, bringing together top police officials from the southern States to strengthen inter-State collaboration, identify critical loopholes, and develop effective strategies to combat online frauds that transcend borders.

Senior officials leading cybercrime investigations from Andhra Pradesh, Telangana, Karnataka, Kerala, and Tamil Nadu will participate.

The focus will be on streamlining cooperation between States and addressing grey areas in investigations that often hinder swift action.

Telangana Cyber Security Bureau Director Shikha Goel said that inputs from Shield 2025 - a cybersecurity conference held on February 18 and 19 - will be shared at the meeting.

"We are compiling key challenges, solutions, and recommendations identified during the summit. These findings will be presented at the Southern States' meeting and also shared with relevant departments to drive necessary reforms. For example, policy-related suggestions will be forwarded to the Central government for action," she explained.

Necessary infusion

The RBI's long-term currency swap was likely forced by financial volatility

he Reserve Bank of India's (RBI) recent decision to inject an additional \$10 billion into the financial system through a dollar/ rupee swap auction is a timely measure aimed at addressing long-term liquidity concerns among domestic lenders. These concerns stem from a flight of foreign capital from Indian stock markets, as investors seek better returns in the United States amid President Donald Trump's proposed corporate tax cuts and ongoing tariff wars, which have strengthened the U.S. dollar against global currencies. This marks the second such rupee infusion in less than a month. However, unlike the first tranche of \$5 billion on January 31, which had a six-month tenor, the latest swap auction has a three-year duration. The combined effect of these two auctions will inject approximately ₹1.3 trillion into the banking system, as lenders deposit their dollar reserves with the RBI in exchange for rupees at a pre-determined buyback premium. Currency swaps are among the tools central banks deploy during periods of high volatility in the global financial system. These measures have the primary aim of stabilising the local currency, mitigating liquidity constraints in the domestic financial system, and curbing inflationary pressures. Economists estimate that an additional \$5 billion infusion may be necessary to neutralise the ₹1.7 trillion liquidity deficit in India's banking system as of February 20, 2025.

This is the second time that the RBI has conducted a long-duration currency swap. The first was in 2019, in response to global financial volatility during Mr. Trump's first term, amid trade tariff tensions and tax cuts. However, unlike 2019, when India's foreign exchange reserves were rising, ensuring dollar availability while rupee liquidity remained constrained, today's situation is more challenging. Between October 2024 and February 21, 2025, the rupee has depreciated approximately 3.3% against the dollar, breaching the 85 per dollar mark on December 19, 2024. Foreign portfolio investors and foreign institutional investors have also withdrawn roughly \$31 billion from Indian equity markets. Since December 2024, the RBI has sold an estimated \$111.2 billion (about 18% of its foreign exchange reserves) to stabilise the rupee. Given these conditions, the latest long-term currency swap appears to be a necessity rather than a proactive measure. Indian banks must capitalise on this liquidity infusion by continuing to extend credit, ensuring that the cycle of capital investment, employment generation, wage growth, and consumer demand remains intact. This, in turn, could help propel India's real GDP growth beyond the current 6.4%, despite prevailing global economic headwinds.

Foreign influence

India's response to tainted aid must be rooted in policy, not rhetoric

India reflects an increasingly unhinged public discourse, undermining the nation's confidence and global standing. The BJP and the Congress have been engaged in a political tug-of-war, attempting to corner each other over USAID-funded projects and foreign connections. However, much of this cacophony that passes for debate is fuelled by misinformation and misinterpretation, often drawing from insinuations made by the Trump administration which views international aid as a waste of American resources. While the U.S. may have its reasons to reassess its aid priorities, it is regrettable that India's major political parties are echoing these arguments without a nuanced understanding. USAID has long supported projects in India, including those in partnership with the government. In the absence of verifiable data on the extent and impact of these initiatives, discussions are bound to be ill-informed and prejudiced. In a globalised world, where countries compete for capital, technology, and talent from across borders, branding political opponents as foreign agents may be an easy propaganda tactic, but poisons the domestic political environment and weakens

India's aspirations to emerge as a global power. It is true that foreign aid can be a tool of soft power, often used by stronger nations to exert influence over domestic affairs of other countries. However, recognising this reality requires a responsible and measured approach, and not an overreaction that borders on self-sabotage. India itself has evolved into an aid provider, a role it seeks to expand. According to an ORF analysis, since 2000, the Ministry of External Affairs has overseen financial assistance exceeding \$48 billion to over 65 countries, through grants, lines of credit, and capacity-building programmes. This growing role, as a donor nation, has coincided with stricter regulations on foreign contributions within India. However, these regulations have been heavily politicised - entities aligned with the ruling establishment often face fewer hurdles, while others, even those engaged in purely apolitical activities, encounter significant restrictions. The American debate over USAID's role in India does raise concerns about foreign influence, but any response must be rooted in clear-headed policy rather than reactionary rhetoric. If the government genuinely suspects that foreign funding is shaping India's political landscape in undesirable ways, it must approach the issue with transparency and a well-defined plan for investigation. Managing national security in an era of increasing global interconnectedness and transnational challenges is a complex task, one that requires a mature, strategic outlook rather than a chaotic, polarised public discourse.

Indian industry needs innovation, not mindless toil

few months ago, this writer and his colleagues interviewed migrant industrial workers in Ludhiana, Punjab, for a research project. The respondents worked in factories (producing garments, auto components, and other products) for 11 hours to 12 hours a day. When orders were high, they worked for days on end without a break. Away from the shop floor, their waking hours were spent almost entirely on cooking and in their daily commute.

It is puzzling that some of the well-known corporate leaders in the country have been urging Indians to work longer hours. They may not be aware that most of India's workers are informal and must work extremely long hours, sweating to earn a living (manual workers or household helpers). In 2023-24, the Periodic Labour Force Survey showed that only 21.7% of India's workers were in regular jobs with a salary, while the rest were casual workers or self-employed. Even within the category of regular workers, approximately half of them had to face informal working conditions (they did not have a written job contract, were not eligible for paid leave, and did not receive any social security

Competing with the cheap labour advantage By publicly expressing their preference for having longer working hours, industry bosses have inadvertently confirmed a well-known, yet not-much-discussed, fact. Indian industry continues to derive its competitive advantage mainly from cheap labour rather than technology and innovation. In the developed world, the mode of surplus extraction underwent a transformation long ago, from making workers labour longer hours to employing them more efficiently with superior technologies and management practices. Based on workers' conditions during the Industrial Revolution in Britain in the 18th century, Marx wrote: "In its ...werewolf hunger for surplus-labour, capital oversteps even the merely physical maximum bounds of the working day. It steals the time required for the consumption of fresh air and sunlight. It haggles over a meal-time...."

However, working conditions in Britain improved by the middle of the 19th century, following regulations brought about by labour union pressures and the sweeping economic and technological changes (although exploitative labour practices continued unabatedly in the colonies). Today, workers in rich countries put in much fewer hours but have significantly higher productivity than those in developing countries.

is a Professor of Economics at the Indian Institute of Technology (IIT) Delhi According to data reported by the International Labour Organization (ILO) in 2024, an employee's average weekly work hours was 38 hours in the United States and 36.6 hours in Japan as compared to 46.7 hours in India.

India's capitalists have deployed one strategy after another to ensure that they have at their disposal a large labour force willing to work long hours for low wages. Big businesses in India have abetted a structural shift in industry from the organised sector, which is governed by regulations of wages and working conditions, to the unorganised sector, where such rules do not apply. In industrial clusters across the country, there is a predominance of small units with six or less workers. At any time in a crowded industrial area in Coimbatore or Ludhiana, one hears the sounds of several hundreds of machines (lathes, milling and rolling machines, foundries) operating in small sheds. Each shed produces a small part or a component that feeds into a production network coordinated by more prominent firms to manufacture a range of products, including pumps, automobiles, and agricultural tools. In most small firms, the owners, often former workers, work alongside the hired labourers. Over 70% of India's manufacturing workforce (68 million in 2021-22) are in small, unregistered enterprises (each with less than 10 workers).

Losing out on innovation

The relations between the small and large firms in India have not been mutually enriching (of the kind that prospered in Japan), but instead, have been enfeebling the small firms even more. In interviews this writer had with them over the years, the owners of small firms highlighted issues relating to payments for the parts or components they supply. The bigger firms typically delay these payments several months after receiving the supply, leaving the small-firm owners desperate for fresh funds to run their factories. The big firms refuse to pay more for the parts despite increases in material and other production-related costs, encouraging a race-to-the-bottom competition among the small firms. All these are at a time when small firms are weakened by inadequate state support, especially bank credit, and rising competition from cheaper

India's factories are increasingly dependent on workers who are employed through contractors rather than those they directly employ. Of all workers who joined India's factory sector after 2011-12, 56% are contract workers. These workers, who are not protected by labour

regulations, are paid much lower wages than directly employed workers. Workers who migrate from their villages to seek jobs in distant lands form the core of the labour supply for Indian

The low wages migrant workers receive manifest their multiple disadvantages - on account of their social position and their lack of ownership of assets or access to social security benefits. As wages have been pushed downward, profits have soared, especially after the outbreak of the COVID-19 pandemic. In India's factory sector, profit as a share of value added was 31.6% in 2019-20, but shot upward to 46.4% in 2021-22.

The garment industry

However, with its over-reliance on cheap labour for growth, the Indian industry has been shooting itself in the foot, hindering its forward movement in the long run, especially globally. A case in point is India's garment industry experience. One expects a labour-surplus India to outshine other countries in this low-wage industry. However, India's share of the worldwide export of garments has remained stagnant at 3.1% over the last two decades. China, Bangladesh, and Vietnam have considerably outperformed India in the garment industry. Chinju Johny and this writer (Economic and Political Weekly, August 24, 2024) have argued that the main barrier to progress for India in this industry is the reluctance shown by the capitalists to modernise firms. They lack the ambition to go beyond the limited advantages that low wages offer them in the domestic and niche segments of the export markets in the garment industry, which western multinational companies dominate.

The easy availability of labour has lulled Indian industry into a stupor, closing its eyes to the wider opportunities and the gaping need for technological and managerial changes. This has undermined growth in all fields, including new-generation ones such as the IT sector. Low wages and long working hours have reduced the purchasing capabilities of the working classes and depressed the domestic market, reinforcing the negative momentum.

Stretching the limits of the working day, allowing little time for recuperation for tired minds and bodies, and having all these driven by the greed for profits, is unconscionable. And the industry's gains, if any, are only in the short run. In the long run, the swelling ranks of impoverished workers will strangle the industry, leaving it gasping for innovation and growth. The earlier the masters of the Indian industry realise this, the better.

Talent shortage — global challenge, India's opportunity +

he global labour market does not seem to be future-ready. No one has the crystal ball to tell the future exactly, but it can be safely said that the skills needed in 2030 will be quite different from what we have today. This is a challenge for the entire world – and an

A recent FICCI-KPMG study, 'Global Mobility of Indian Workforce', has estimated that by 2030, the demand for skilled workers will exceed supply, leading to a talent shortage of over 85.2 million people. "This global skills shortage could result in estimated \$8.45 trillion in unrealised annual revenue by 2030 – equivalent to the combined GDPs of Germany and Japan," the study says. For India, the challenge, and the opportunity, is to grab as large a slice of the 8.45 trillion pie as soon as possible.

Addressing this challenge requires targeted strategies, international cooperation and proactive policy interventions to optimise workforce mobility and economic productivity. At the national level, the need of the hour is a properly coordinated effort among government, the private sector and other stakeholders.

Geographic regions and their demands The Gulf Cooperation Council (GCC), Europe (including the United Kingdom) and Australia emerge as three key geographies where workforce mobility will be critical. The talent shortage will neither be uniform across all regions nor follow similar patterns. Each of these regions faces specific workforce demands. However, health care will be a common requirement across all three regions, with aging populations and increasing health-care needs driving demand. In general, services will be prevalent in the three geographies. Manufacturing and construction are pivotal for the GCC and Australia, while Europe, being the oldest post-industrial society, will require more service-sector workers. Besides, there are emerging sectors. Existing barriers and strategies

There are several barriers that obstruct the efficient movement of skilled workers across borders. Some of these are regulatory and immigration barriers (complex visa processes and stringent work permit regulations hinder skilled migration) and recruitment malpractices and trafficking (exploitative recruitment practices and human trafficking that pose serious threats to migrant workers' safety and rights). In his recent visit to the United States, Prime Minister Narendra Modi highlighted this menace and underlined the need to fight it. Other obstructions include policy barriers and skill mismatches (many Indian degrees, particularly in medicine, are not recognised everywhere in Europe, leading to underemployment or unemployment of qualified professionals) and language and cultural barriers (integration challenges, including language proficiency and cultural adaptation, affect workforce efficiency and productivity).

The Government of India has initiated various programmes to address the challenges. These include Bilateral Agreements and Free Trade Agreements (FTAs) – India has several agreements with the GCC nations to protect the rights of Indian workers. For instance, the Joint India-United Arab Emirates Vision recognises the importance of skill cooperation between the two nations. Some other notable initiatives are skill development programmes to align workers' skills with global market needs and digital platforms for workforce support, where online recruitment systems are focused on ensuring legal protections for workers and shielding them from fraudsters, particularly in GCC countries.

To capitalise on the global demand for skilled labour, several strategic measures should be prioritised which include sector-specific skill training (workforce training should be aligned with the needs of target geographies and preparation must be made for emerging sectors); regulation of recruitment practices (authorities

must implement stricter oversight on recruitment agencies to prevent exploitation and trafficking); recognition of qualifications (international collaborations must focus on mutual recognition of academic and professional qualifications to ease workforce integration); incentivising public-private partnerships (governments Centre and in the States should encourage private sector involvement in training programmes and global employment facilitation) and promoting circular migration and mobility (temporary work visas and rotational workforce models can address labour shortages without causing demographic imbalances).

The political climate regarding immigration policies is ever-changing. While Europe may tighten its regulations, Australia remains more open to skilled migration. In the FICCI-KPMG study, the Indian diaspora is the second largest and fastest growing diaspora in Australia.

Join FREE Telegram Channel India's advantage https://t.me/+Bu7senHpOdhlODg1 At any rate, strict immigration policies mainly target illegal migration. India must remain resilient in its efforts to position its skilled workforce globally, undeterred by shifting political rhetoric. A major advantage for Indian workers is the absence of significant hostility towards them, and towards India, in most global markets. Even in countries with growing anti-immigration sentiments, skilled Indian workers continue to find opportunities. However, to maintain and enhance this position, the Indian government must take measures to curb illegal migration. Preventing illegal immigration will not only protect Indian workers from exploitative agents but also enhance India's global reputation as a reliable supplier of skilled labour.

This will also help us realise the dream of becoming Viksit Bharat. The Chairman of the Sixteenth Finance Commission, Arvind Panagariya, recently projected that India's GDP could reach between \$6.5 trillion and \$9 trillion by 2030. India's ability to move closer to the \$9-trillion mark will be directly linked to how much of the estimated \$8.45 trillion in unrealised global economic potential it can tap into.

A new age of imperialism

n Ernest Hemingway's *The* Sun Also Rises, a character is asked how he went bankrupt. "Gradually and then suddenly," he says. So, too, perhaps with the rules-based international order that has governed relations between member states, after the dizzving first weeks of the second Trump presidency. Three years ago, when Russia invaded Ukraine, the violation of the UN Charter by a permanent member of the Security Council severely tested the principles upon which the post-war order had been built. It exposed the fragility of an open, rules-based international system founded on the three pillars: economic integration through a global trading system and international financial institutions; collective security based on sovereign equality; and self-determination. However, today, the U.S. has switched from backing Ukraine to echoing Russia in a repudiation of the Charter principles. This has dealt a body blow to the UN-based system of global governance.

The birth of the world order The current world order rose from the ashes of World War II. Over several conferences between 1941 and 1945, the U.S., the U.K., and the Soviet Union agreed to the formation of an international organisation based on collective security to maintain peace and manage relations between states as sovereign equals. Beneath the lofty principles was a hard-nosed recognition that loyalty to the system rested on calculations of self-interest. It was therefore decided at the Tehran Conference of 1943 between Winston Churchill, Theodore Roosevelt, and Joseph Stalin that this organisation would enforce peace through 'four policemen': the U.S., Britain (then still an imperial power), the Soviet Union, and China (the latter two were needed to fight Japan). By the Yalta Conference of 1945, France was included at the top table, mainly

been occupied by the Third Reich. The imposition of a victor's peace was avoided by insisting on the sovereign equality of all states in a rules-based order. Great power rivalries would be managed by a system of collective security and economic integration. In reality, however, the 1945 Yalta Conference implicitly accepted spheres of influence for the Soviet Union in eastern Europe and, by extension, for the U.K. and the U.S. in the rest of Europe. This was the price for Stalin's agreement to fight with the Allies against Japan.

Yet, flawed though it was, the UN system, the Bretton Woods organisations, and subsidiary organisations lubricated the conduct of relations between states. Even if war did not disappear, the system privileged norms and principles that made international relations more predictable and consensual and fettered the power of larger states to the ideals of a rules-based forum of sovereign equals. In time, spheres of influence yielded to self-determination.

Upending the world order President Donald Trump has taken a bulldozer to this system. He has undermined international agreements by pulling the U.S. out of the Paris Agreement, signalling its departure from the World Health Organization, and ordering a review of American membership of all international organisations and treaties. And by unilaterally imposing tariffs on trading partners, he has thrown the global trading system into complete disarray. Overnight, norms and expectations of behaviour from a founding member of this international order have been upended. The U.S., the most powerful nation, is behaving like a declining power, pursuing a nationalist foreign policy, seeking to expand its influence and borders within its hemisphere, and promoting its economic and mercantilist interests.

reinstatement of ties with Vladimir Putin. His attempts to negotiate a peace in Ukraine without Kyiv at the table, calling Volodymyr Zelenskyy a dictator, and agreeing to Russian demands that no NATO troops set foot on Ukrainian soil to enforce any 'peace' that is negotiated have stunned Europe. Europe has to come to terms with managing its own security, having ridden on the U.S.'s coattails for decades within NATO. The meeting between American and Russian officials at Riyadh may not have been a Yalta moment, but the

Ukraine's former backer. The rhetoric from the White House (and Mr. Trump's Truth Social account) signals a new world order that is nasty and brutish and in which might makes right. The U.S.'s retreat from the global stage to its neighbourhood, while Mr. Trump tries acquiring Greenland, Canada, the Panama Canal, and perhaps Gaza, may seem the stuff of fantasy, but if he is to be taken at his word, it signals the start of a new imperial age.

The world is being divided into spheres of influence. The U.S. will exert power on its own hemisphere, and perhaps on West Asia. By repeating Mr. Putin's lines on Ukraine and NATO expansion, Mr. Trump has effectively handed over Europe to Russia, leaving Mr. Putin free to pursue his revanchist claims on Ukraine and recreate imperial Russia's lost glory.

That leaves China, which has propped up Russia through its Ukranian adventure. Beijing's irredentism regarding Taiwan has so far been held in check by the U.S.'s security guarantees in East and Southeast Asia. America's retreat leaves China free to consider moving on its claims to Taiwan. India would do well to remember that China has never accepted the McMahon Line. Suddenly, along with the world order, our neighbourhood too is starting to look more insecure.

An early shift to election mode

The Tamil Nadu political landscape has changed significantly since 2021

amil Nadu still has about 15 months to go before it faces Assembly elections, but major political parties have already begun re-jigging their respective organisations to get them ready for the big battle.

Earlier this month, the ruling Dravida Munnetra Kazhagam (DMK) bifurcated its district units and created four new units. It also gave representation to members of certain key communities. Some sulking seniors have been assuaged, weaklings removed, and those who switched over from the All India Anna Dravi-Munnetra Kazhagam (AIADMK) rewarded.

The AIADMK followed suit by appointing front-line leaders for its 82 district units. They have been tasked with visiting their respective districts and submitting reports by the end of March.

The political landscape has changed significantly since M.K. Stalin took oath as Chief Minister in the midst of CO-VID-19 in May 2021. While the DMK's eight-year-old rainbow alliance is largely intact, the front that the AIADMK headed four summers ago is in a shambles and so is the party. Last year, during the Lok Sabha polls, for the first time, the Bharatiya Janata Party headed an alliance and bettered its electoral performance; Seeman's Naam Tamilar Katchi (NTK) was recognised as a State party; and actor C. Joseph Vijay launched the Tamilaga Vettri Kazhagam (TVK).

Alliances have been indispensable for the two Dravidian majors for capturing power, barring 2016, but it is



too early to predict how they will take shape. What is clear, though, is that 2026 will not be a cakewalk for any party. Notwithstanding the strengths of the alliances, the NTK and TVK, if they contest on their own, could damage the prospects of the principal forces.

Despite saying that the DMK will easily win more than 200 Assembly seats, Mr. Stalin is leaving nothing to chance. He knows that it will be perilous to underestimate the potential of the AIADMK, even if the party has its own woes and weaknesses; the AIADMK could still forge a strong alliance and challenge the DMK.

Mr. Stalin hit the ground running late last year. He has been going on two-day tours to various districts, conducting roadshows, and meeting people. Video footage of Mr. Stalin eating halwa from Tirunelveli's famous sweets shop, Iruttu Kadai, and meeting with goldsmiths in Coimbatore is reminiscent of his earlier political roadshows, such 'Namakku Naame (We stand for ourselves)' in 2015-16 and 'Ungal Thogithiyil Stalin (Stalin in your constituency) in 2021. The DMK is focused on projecting him as a father figure; Mr. Stalin says he is overjoyed when young people address him as 'Appa (father)'. He has also launched an app, APPA (Anaithu Palli Parent Teachers Association), which is designed to bridge the communication gap between parents, teachers, and the administration. This has inevitably resulted in people wondering if the attempt is to draw parallels between him and the late AIADMK leader, Jayalalithaa, who took pride in being called 'Amma (mother)'. The DMK is also aware that

its populist schemes, outreach programmes, and claims of having fulfilled 90% of its 505 electoral promises will not guarantee it a second consecutive term in office unless State government employees are convinced that they should vote for it. This section is disillusioned that the government has not restored the Old Pension Scheme (OPS). In an attempt to placate them, this month the government constituted a three-member committee to study the OPS, the Contributory Pension Scheme, and the Unified Pension Scheme, and submit a detailed report with recommendations within nine months.

AIADMK general secretary Edappadi K. Palaniswami has also been touring various districts and addressing public meetings, while battling discontent within and trying to manoeuvre a soft salvo by partv veteran K.A. Sengottaivan. As he had to face the ignominy of AIADMK candidates forfeiting deposits in seven Lok Sabha constituencies last year, and traditional support from the Mukkulathors has eroded after former coordinator O. Panneerselvam's expulsion from the party, Mr. Palaniswami feels compelled to forge a politically creditworthy alliance. He also has to contend with external attempts aimed at preventing the AIADMK from allying with newer political forces in the State.

The political landscape is pregnant with possibilities. It is difficult to judge now which way the wind will blow.

Manipur's GST growth rate declines, inflation surges

Thousands of hours of Internet shutdowns have added to the State's woes

he ongoing conflict in Manipur has had a significant impact on the State's economy. The revenue flow from GST has slowed down drastically, while retail inflation levels have skyrocketed. The double whammy came amid over 1,000 hours of Internet shutdowns last year preceded by more than 4,300 hours in 2023. While ethnic violence continues to lead to numerous deaths, the theatre of conflict has now shifted to the peripheral districts of Jiribam and Kamjong.

While the growth rate of GST revenues from Manipur was among the highest across all States between FY18 and FY19 and between FY19 and FY20, it was among the lowest between FY23 and FY24. Manipur collected ₹670 crore in GST revenues in FY24, an 8.9% increase from FY23 – the fifth lowest growth rate among 31 States and Union Territories. In contrast, it had ranked second and third in India in terms of GST growth rate in FY18-FY19 and FY19-FY20.

Chart 1 compares the GST growth rates for India and Manipur. Manipur's GST growth rate was 2.5 times higher than India's between FY18 and FY19, and five times higher than India's between FY19 and FY20. However, in FY23-FY24, Manipur's GST growth rate was three-fifths of India's.

While the rise in cost of living, driven in part by an increase in food prices, is a pan-India concern, the rise in retail inflation is pinching the wallets of Manipuri consumers more than anywhere else in the country. Before the start of hostilities in May 2023, Manipur had the lowest retail inflation among all the States. In January 2023, while the average Indian retail inflation was exceeding 6%, it was just 1.7% in Manipur. In May

2023, while the average inflation in India was 4.3%, inflation climbed to 9.5% in Manipur, the highest among all the States.

Since then, inflation in Manipur has remained higher than the all-India average across most months. The inflation rates in May, June, and July 2024 were the only exceptions to the trend and this was mainly due to the base effect. In January 2025, while Indian retail inflation eased to a five-month low of 4.3%, the corresponding number was 7.4% for Manipur (Chart 2).

Apart from price rise, Internet shutdowns have disrupted life and work in Manipur in the last two years. An Internet shutdown was first imposed in the districts of Churachandpur and Pherzawl on April 28, 2023. It was extended to the whole State on May 3, 2023, following communal clashes. The Internet shutdown in Manipur lasted 200 days in 2023, which is the longest in the north-east and the second longest in the country after Jammu and Kashmir. Shutdowns continued in 2024, with the latest recorded last December.

A district-wise breakdown of Internet shutdowns since 2023 shows that Churachandpur is the worst affected (about 30 shutdowns) followed by Imphal East, Imphal West, Bishnupur, and Thoubal (more than 25 shutdowns each). Kakching and Kangpokpi have experienced 23 and 21 shutdowns, respectively.

As noted before, the theatre of conflict has shifted. In the first year of the conflict (May 2023 to June 2024), the majority of conflict-related fatalities were concentrated in the districts of Imphal east, Imphal west, Bishnupur, Kangpokpi, Kakching, Thoubal and Tengnoupal (Map 3A).

However, communal tensions began to rise in the peripheral district of Jiribam after the murder of a Meitei farmer in June 2024. From the second half of 2024 (Map 3B), while fatalities occurred everywhere, many were reported from the Jiribam and Kamjong districts.



Swiss firm's move hits Bangalore watch unit

New Delhi, Feb. 22: Asuag of Switzerland, a monopolistic entity controlling the Swiss watch industry, has caused serious dislocation to a Bangalore firm, having a technological tie-up with a Swiss firm for the manufacture of electronic watches by choking off all credit facilities to its Swiss collaborator, Bernard Golay.

The Bangalore firm is now making strenuous efforts to go to the rescue of its Swiss partner, and keep its own manufacturing programme going, by taking up shares in the Swiss company. It has asked the Union Government permission to do so and for release of foreign exchange to the tune of about two million Swiss francs (About Rs. 6 millions) for this purpose. It has also made an alternative proposal for the release of a similar amount to enable it to buy the technological documentation from Bernard Golay.

In recent years, despite all its assurances to the contrary, it appears that Asuag has become increasingly alarmed over the progress being made by the watch industry in India. Though the Swiss industry has disowned any responsibility for the smuggling of Swiss watches into India, it has been widely suspected that such smuggling has been thriving with its connivance.

A HUNDRED YEARS AGO FEBRUARY 24, 1925

Drugging babies in industrial areas

London, Feb. 23: In the Commons, Mr. Johnstone drew attention to the fact that medical evidence showed that 98 per cent of the children born in the industrial area of Bombay were drugged with opium, so that they might sleep and not cry for food while their mothers were working in factories. He declared that infant mortality in Bombay was 666 per thousand compared with 80 per thousand in London. Asked as to what steps he proposed to take in the matter, Earl Winterton replied that Lord Birkenhead had been informed that the Government of Bombay was considering the question of the administration of opium to children. According to official statistics, infant mortality in Bombay was 178.11 per thousand and not 666.

What has SC previously ruled on gag orders?

What were the stringent conditions imposed on podcaster and influencer Ranveer Allahbadia by the Supreme Court? What are the factors on which the top court grants interim relief to the accused in a case? What has the Court said about gag orders in the past?

The story so far:

he Supreme Court on February 18, granted interim protection from arrest to podcaster and influencer Ranveer Allahbadia in connection with the First Information Reports (FIRs) registered against him over remarks made on the YouTube show "India Got Latent". A Bench comprising Justices Surya Kant and N. Kotiswar Singh imposed stringent conditions, prohibiting Allahbadia and his associates from posting any content on social media until further orders. The court also directed him to surrender his passport to the police. These conditions contravene prior SC rulings that have cautioned against the imposition of onerous restrictions that unduly curtail personal liberty while granting interim relief.

What was Allahbadia's plea?

Multiple FIRs were registered against Allahbadia in Maharashtra, Assam, and Rajasthan under various provisions of the Bharatiya Nyaya Sanhita (BNS), 2023, the Information Technology Act, 2000, and the Indecent Representation of Women (Prohibition) Act, 1986, for allegedly promoting obscenity and engaging in sexually explicit discussions.

Consequently, he approached the Supreme Court seeking a consolidation of these FIRs and an interim order granting him protection from arrest. Such petitions, akin to anticipatory bail applications, are entertained under Article 32 of the Constitution for the enforcement of fundamental rights and to shield individuals from arbitrary police action. In such cases, courts either club the FIRs or permit the investigation to proceed under a single one while staying the rest. This spares the accused from the hassle of appearing before multiple courts. typically assess three key factors: flight risk (the likelihood of the accused absconding); intimidation of witnesses (apprehension that the accused may threaten witnesses); and tampering with evidence (the possibility that interim relief could enable the accused to interfere with the investigation).

For instance, courts often impose bail conditions such as requiring the accused to deposit their passport, setting a high bail bond to ensure their participation in the investigation, and mandating periodic appearances before the concerned police authority. However, the Supreme Court has consistently cautioned against imposing unduly restrictive conditions, such as requiring the accused to share their Google Maps location PIN or reside in a specific locality, deeming them disproportionate and unwarranted.

In Satender Kumar Antil versus Central

Bureau of Investigation & Anr (2022), the top court ruled that imposing bail conditions that were "impossible of compliance" would be defeating the very object of release. More recently, in Frank Vitus versus Narcotics Control Bureau (2024), a Bench comprising Justices A.S. Oka and Ujjal Bhuyan ruled that a bail condition requiring the accused to share their Google Maps location PIN was unconstitutional. "The investigating agency cannot be permitted to continuously peep into the private life of the accused enlarged on bail by imposing arbitrary conditions since that will violate the right of privacy of the accused, as guaranteed by Article 21", they observed.

Is this case different?

The condition imposed on Allahbadia and his associates to "not air any show on Youtube or any other audio/video visual mode of communication till further orders" effectively constitutes a gag order. In free speech jurisprudence, this falls under the doctrine of "prior restraint" state action that prohibits speech or expression before it occurs.

Courts have consistently cautioned against prior restraints on speech, deeming them impermissible except in exceptional circumstances. In 2021, the Supreme Court stayed a Kerala High Court bail condition restricting woman rights activist Rehana Fathima from publishing her views on social media. Notably, while granting interim bail to Alt News co-founder Mohammed Zubair in 2021, a Bench led by Justice D.Y. Chandrachud and also comprising Justices Surya Kant and A.S. Bopanna rejected the Uttar Pradesh government's request to prohibit him from tweeting while on bail. The Bench underscored that such a disproportionate restriction would create a "chilling effect on the freedom of speech." The court further noted that Zubair's profession required him to engage with social media and underscored that a gag order would constitute an "unjustified violation" of the right to practise his profession."

Why has the UGC-CARE list of journals been discontinued?

What are the suggestive parameters introduced by the University Grants Commission with respect to academic journals? Will it lead to a proliferation of low quality journals?

The story so far:

he University Grants Commission (UGC) decided to discontinue the UGC Consortium for Academic and Research Ethics (UGC-CARE) list, which is a list of quality academic journals, first introduced in 2018. The UGC-CARE list will now be replaced by a set of suggestive parameters for choosing journals based on eight criteria. Stakeholders can submit suggestions by February 25.

What do the new parameters say?

There are about 36 suggestive parameters under eight criteria in the draft notification titled "Suggestive Parameters for Peer-Reviewed Journals." Under the journal preliminary criteria, the UGC has asked teachers to note the journal title,

the international standard serial number, periodicity and continuity and transparency review policy etc before sending an article for publication. Under the editorial board criteria, the UGC wants authors to ensure that the journal's editorial board details and editorial board composition are made available. Similarly other criteria under suggestive parameters include journal editorial policy, journal standards, journal visibility and research ethics.

Why did the UGC withdraw it?

The aim of the UGC-CARE listing was to ensure that only "reputable" journals are recognised for faculty selections, promotions, and research funding applications. According to UGC Chairman M Jagadesh Kumar, the UGC-CARE list faced several criticisms, including over-centralisation in deciding what

constitutes high-quality research and journals, and unnecessary delays in including or excluding journals from the list. Academics had also raised concerns that in certain fields, such as Tamil, the availability of research journals were limited as per the UGC CARE list. Mr. Kumar said there was lack of transparency in the decision-making process and highly respected journals published in Indian languages were excluded from the list.

Furthermore, the UGC claims that the new approach will help in combating predatory journals and decentralise the mechanism of choosing academic journals. Higher education institutions will "now be responsible for establishing credible mechanisms to evaluate journals and ensure they meet high ethical and scholarly standards." They can develop their own institutional mechanisms for

evaluating the quality of publications and journals. "These mechanisms should align with established academic norms and indicative parameters suggested by the UGC. This decentralised approach allows HEIs to tailor their evaluation processes to suit their specific needs," Mr. Kumar said in a statement. Institutions can now create evaluation models that consider the unique characteristics of different disciplines, and accommodate newer, evolving fields.

What has been the response?

Students and academics have voiced their concerns on the latest move. Their main worry is that the decision will result in the mushrooming of low-quality journals. The Central Executive Committee of the Students' Federation of India (SFI) condemned the UGC's move, which they said was taken without adequate consultation with student and research communities. The SFI termed the decision as a serious setback to academic integrity and quality research in India. The SFI added that the UGC's decision is part of a broader pattern of deregulation in higher education under the National Education Policy (NEP) 2020. "While decentralisation is essential for academic freedom, the lack of a central oversight mechanism could lead to arbitrary and inconsistent journal evaluation processes

across institutions," it said.

What does the AWS-Adarsh Developers case say about cloud data management?

Adarsh Developers said that it was using Amazon cloud to secure the company's financial data and customers' personal data. However, on January 9, the company said, the data environment hosted on AWS was completely deleted

The story so far:

n February 11, Bengaluru-based Adarsh Developers filed a complaint against Amazon Web Services (AWS), claiming that years' worth of company and customer data hosted on AWS was lost, resulting in a financial loss of well beyond ₹100 crore. The loss of data and Adarsh Developers' decision to take legal action against the tech giant in India has raised questions about security in enterprise-grade cloud storage, the need for multiple versions of backed-up data, and the legality of such cases.

What happened?

In its FIR filed on February 11, Adarsh Developers said that it was using SAP ERP hosted on Amazon cloud to secure the company's financial data and customers' personal data. The real estate firm alleged that in May 2023, AWS's business development representative Saidalawi Safan advised the company to opt for an upgraded service to secure their data, so as to ward off cyberterrorism or sabotage. They complied. But on January 9, 2025 at 10.48 AM., the company said, the data environment – the entire SAP S/4HANA environment, to be specific-hosted on AWS was completely deleted.

partner SAVIC Technologies Pvt. Ltd., Adarsh Developers said that the data loss was a result of the action taken by individuals at Redington, a vendor, and AWS. The participants' exact actions and the specific allegations against them are

The real estate company further claimed that years' worth of vital financial records, supply chain data, customer information, and operational insights had become inaccessible. The loss of the data brought its business functions and operations to a complete halt, Adarsh Developers said in their complaint. The company estimated that the value of the data it lost to around ₹150 crore as of January 31, with approximate losses of ₹5 crore per day starting from January 9.

Adarsh Developers also said that it was unable to collect customer payments, pay statutory taxes, and facilitate interest payments to lenders.

The cybercrime police has registered a case against AWS and others, under the IT Act, Section 318(4) (cheating and fraud), and Section 319(2) (impersonation) of the Bharatiya Nyaya Sanhita.

How might the data have gone missing?

There is a general tendency to think data loss is a result of actions performed by malicious agents, such as hackers or even disgruntled employees. However, there

can be a number of reasons behind data loss, especially when teams of vendors, technical partners, clients, service-providers, and consultants work together to keep a company's complex systems up and running in a secure

environment.

One possibility is cloud misconfiguration, which stems from poorly implemented cloud storage settings, bad system architecture, low-quality security infrastructure, unsecured databases, or unmanaged access. Human error is also a common cause for large-scale outages and data loss incidents. In the FIR, Adarsh Developers cited SAVIC's claims that some individuals in the Redington and AWS teams were responsible for the data loss, and that, "...employees at Redington Group have entered into our storage area at root level and deleted our account completely."

However, it is not possible to pinpoint the exact cause of the data loss and those behind it until a comprehensive forensic investigation is carried out and the results backed up by evidence. For this to happen though, Adarsh Developers, Redington, SAVIC, and AWS will all have to present their claims and technical data to make sure they are in the clear.

What was Amazon's response Adarsh Developers claimed that AWS India responded by saying that they could Join FREE Telegram Channel https://t.me/+Bu7senHpQdhlODg1

not retrieve the data or restore it, forcing the real estate company to take legal action. Amazon, however, has refused to accept Adarsh Developers' allegations. "The claims against AWS are false. AWS operated as designed and is not responsible for the deletion of Adarsh Developers' data," said an AWS spokesperson in response to The Hindu.

Have such cases happened before?

While the root cause of Adarsh Developers' data loss incident is not yet clear, some similar incidents involving data loss through cloud services have been recorded in the past.

For example, The Register outlet reported that the Microsoft Azure outage of January 29, 2019 affected Azure SQL databases and also led to some data loss within a certain time window. To compensate users, the company waived a few Azure usage charges for 2-3 months, depending on how the databases were affected, per *The Register*. Even before this, code-hosting platform Code Spaces had to shut down after its servers were hit by a DDoS attack and its Amazon Web Service account [Amazon Elastic Compute Cloud (EC2)] was breached by a hacker. Most of the platform's data and its backups (including offsite backups) were deleted, said Code Spaces.

Rescue team yet to contact trapped workers



nister N. Uttam Kumar Reddy visited the accident site and reviewed the rescue work. SPECIAL ARRANGEMENT

No heavy machinery could be moved inside as train tracks laid for moving workers and technical staff in the tunnel proved to be a hindrance. However, a large-capacity diesel generator made its way inside with the help of a train to meet the power needs of the excavation work.

Irrigation Minister N. Uttam Kumar Reddy, who visited the accident site, reviewed the rescue work with team leaders and Irrigation Department officials. Later, he stated that the State government had requested the services of the Navy's elite commando force, Marcos, which has expertise in the underwater rescue operations.

Efforts of the rescue teams to ascertain the condition of those trapped inside were unfruitful as they could not communicate or establish any contact with them. The Army personnel called out names of the trapped personnel through a portable public address system from the closest point to the accident site, hoping to get a response, but

It is being assessed that the persons trapped inside could have fainted or were unconscious due to lack of food and water since Saturday morning even if the air being pumped in is assumed to be reaching them. The heat, pressure and anxiety could have made them faint even if they are alive.

The rescue teams are going on the locomotive till 11.5 km inside, on a conveyor belt set up to bring out excavated material for another 2 km and from there, by foot.

Trump attacks USAID again amid DOGE charge

This week, Indian media and the Washington Post also published investigations speaking to officials at the USAID and documents where they said there was no evidence of a "voter turnout" project for India at all.

The DOGE has not responded to The Hindu's written requests for further details of the alleged allocations for India. The Ministry of External Affairs, which had said on Friday that the allegations were "deeply troubling" and that relevant government departments were looking into the issues involved, has declined to comment on Mr. Trump's latest remarks.

A study of archived versions of the agency's websites also provide some discrepancies.

Since the freezing of all foreign funding by the USAID and suspension of staff by the DOGE, websites of the USAID and the USAID-funded consortium of NGOs called the "Consortium for Elections and Political Process Strengthening" have been taken down. An archived version of the CEPPS Website does not list India amongst the 45 countries it has operated in (2015-2020).

However, some of the NGOs that are part of the consortium have run projects in India, including the 2012 memorandum of understanding with the Election Commission for electoral training, which was renewed in 2020. The consortium's funding reports show that in 2018 and 2019, a figure of approximately \$319,000 were approved for expenses, far lower than the figure of \$21 million.

USAID funded 7 projects in India in FY24: report

Finance Ministry report says U.S. agency funded projects worth \$750 million related to agriculture, food security, water, sanitation and hygiene, disaster management, health, and renewable energy

"Currently, seven projects worth a total budget of \$750 million (approx.) are being implemented by USAID in partnership with Government of India," says the Finance Ministry annual report for 2023-24.

For the financial year 2023-24, an obligation of a total of \$97 million (about ₹825 crore) has been made by USAID under the seven projects, it said.

The Department of Economic Affairs under the Finance Ministry which is the nodal department for bilateral funding arrangements has also shared the

details of projects funded in 2023-24 in the report.

Funded projects

During the year, no funding was made for enhancing voter turnout but to projects related to agriculture and food security programme; water, sanitation and hygiene (WASH); renewable energy; disaster management and health.

Besides funds were committed for Sustainable Forests and Climate Adaptation Programme and

Energy Efficiency Technol-Commercialisation and Innovation Project.

On February 27, the Army chief will visit the Neuve Chapelle Indian War memorial to lay a solemn wreath in honour of the fallen Indian soldiers who participated in the First World War.

The Sambhal district administration in Uttar Pradesh is planning to install over 300 CCTV cameras at 127 locations across the city to bolster security and surveillance. This comes following violence in November last year in which five persons were killed

The project, funded unsion grant, will be implemented as part of the city surveillance initiative, municipal executive officer

Mani Bhushan Tiwari said. "We proposed this plan to ensure security and monitor any future incidents effectively," he said. The CCTV cameras will be installed at major intersections, key locations, and entry and exit routes of the

The system will include Automatic Number Plate Recognition (ANPR) cameras and Pan Tilt Zoom

(PTZ) cameras with voice controllers. The administration will establish two centralised control rooms for monitoring the cameras and the data collected. They will be operated jointly by municipal authorities and the local police. "After completion, they will help us to do real-time tracking, strengthening Sambhal's security framework," Mr. Tiwari said.

Sambhal witnessed violence on November 24 last year, the second day of the Shahi Jama Masjid survey ordered by a local court. Demonstrators assembled near the mosque and clashed with the police personnel deployed there. The police have denied allegations that they fired at the crowd. Five people died and

several were injured in the clashes. The Supreme Court later ordered the Sambhal trial court to halt proceedings in the case and also the mosque survey. The police have arrested over 50 people in the case so far.

UNESCO heritage tag sought for Shivaji's forts

American Airlines flight to New Delhi diverted to Rome

An American Airlines flight from New York to Delhi was forced to divert to Rome on Sunday evening. The Italian Air Force scrambled fighter jets to escort the aircraft to the airport. American Airlines Flight AA292 took off from New York on Saturday for a 14-hour journey. With four hours left to reach the destination, the aircraft took a U-turn after crossing Azerbaijan, according to flight tracking website Flightradar24. Flightradar reported that the diversion was due to a bomb threat. However, there was no official statement from the airline. After being escorted by Italian Eurojet fighter planes, the flight landed at Rome's Fiumicino airport.

Uttar Pradesh Chief Minister Yogi Aditvanath on Sunday said 62 crore devotees had come to Maha Kumbh so far and out of about 120 crore Sanatan Dharma followers in the world, half of them had already taken the holy dip.

Addressing the seers in the presence of Kanchi Kamkoti Peeth Shankaracharya Shankara Vijayendra Saraswati at the Maha Kumbh Mela Mahotsav held at Mahakumbh Nagar, he said, "Which is that religion and sect in the world where such a large number of devotees are coming and expressing their faith within a specific time frame?"

He said, "This [Kumbh] has become a medium for the followers of Sanatan Dharma to express their gratitude towards their seers, the 'Rishi' tradition of India, their 'Dev' tradition and their festivals and celebrations." He added that the Kanchi Kamakoti Peeth had always been at the forefront of promoting Sanatan Dharma. Speaking at an event in Agra, he said the gathering of such a large number of people during a certain period in itself is "one of the rarest events of the century".

Health Ministry bans export of drugs containing Tapentadol, Carisoprodol

Following reports about the export of unapproved combination drugs containing Tapentadol and Carisoprodol by Aveo Pharmaceuticals, Mumbai, to certain countries in West Africa, the Health Ministry on Sunday issued a stor tivity order and immediate withdrawal of export noobjection certificate (NoC) and manufacturing licenc-

es for the combinations. Tapentadol is an opioid medication that is used to treat moderate to severe pain. Carisoprodol is a muscle relaxant which works on the centres in the brain and spinal cord to relieve pain.

"Both Tapentadol and Carisoprodol are individually approved by the Central Drugs Standard Control Organisation [CDSCO] in India. Tapenta-

dol is approved in 50, 75,

and 100 mg tablet forms, as well as 100, 150, and 200 mg extended-release tablets. However, the combination of Tapentadol and Carisoprodol is not approved in India. Neither of these drugs is included in the Narcotic Drugs and Psychotropic Substances (NDPS) list in India," the Health Ministry said.

In a release issued on Sunday, the Ministry said that to ensure regulatory compliance across the pharmaceutical sector, the CDSCO, in collaboration with State regulators, initiated risk-based inspections of drug manufacturing and testing firms in December 2022. As of now, 905 units have been inspected, resulting in 694 actions being taken. These actions include stop production orders, stop testing orders, licence suspensions/cancellations,

warning letters, and showcause notices, depending on the severity non-compliance.

Comprehensive audit

Listing the actions taken by the Health Ministry, the release said a joint team from the CDSCO and the State Regulatory Authority conducted a comprehensive audit of Aveo Pharmaceuticals between February 21 and 22. The findings from

the audit led to the issuance of a stop activity order, halting all operations the premises.

Following the audit, the investigation team seized all raw materials, in-process materials, and finished products. Approximately 1.3 tablets/capsules and 26 batches of APIs (Active Pharmaceutical Ingredients) of Tapentadol and Carisoprodol were seized to prevent further distribution of these potentially dangerous drugs

The Maharashtra FDA issued a stop production order on Saturday and issued communications to all State Drugs Control Authorities and Zonal Offices to immediately withdraw export NoCs and manufacturing licences granted for any combination of Tapentadol and Carisoprodol.

XR Creator Hackathon throws open opportunities for myriad aspirants

Born with a clubfoot, S. Bala Subramaniyam, 27, a postgraduate from Chennai, was no stranger to mobility challenges and societal biases. Despite holding two Extended Reality (XR) patents, he struggled to find opportunities in the industry. However, the XR Creator Hackathon, organised under the Information and Broadcasting Ministry's "WAVES" initiative, has provided him with a platform to showcase his ideas.

Wavelaps founder Ashutosh Kumar, who is the nodal officer of the hackathon, told The Hindu: "Mr. Subramaniyam said the XR industry had been difficult to make an entry as most companies prioritised candidates with conventional tech degrees, making it hard for innovators like

him. However, the XR Creator Hackathon provided him with an opportunity to present his ideas. Mr. Subramaniyam said many individuals, due to physical limitations, are unable to travel for work, education, or medical treatment, but XR technology can break these barriers by bringing the world to them".

Subramaniyam's team, XR Titans, is developing a Virtual Reality so-

lution for enabling remote medical diagnosis and surgery using 3D Magnetic Resonance Imaging (MRI) visualisations. While physiotherapy often is painful, repetitive, and expensive, he is of the view that it can be transformed into an interactive experience using XR-based gaming.

The challenge which was launched in August 2024 saw registration of over 2,200 aspirants - rang-

ing from hobbyists, workprofessionals, students, freelance professionals, entrepreneurs, and academicians to social workers – from about 250 cities in over 25 States and Union Territories. About 30% of the participants were women.

The XR Creator Hackhon is being organised by Wavelaps in association with the WAVES 2025 initiative of the Ministry. Bharat XR and XDG, two XR communities within India, are co-organisers. With the WAVES grand finale set from May 1 to 5, the top five teams will showcase their innovations. The finalists are exploring various domains for XR/VR applications. Many of them are focusing on "healthcare, fitness, and well-being" for solutions enhancing medical training, mental wellness, and personalised fitness experiences.

Prapatti, the prescribed way

Parasara Bhattar, in his Rangaraja Stava, first praises his father Kooratazhvan and then his own Acharya – Embar. His next verse of praise is about Ramanujacharya, who, he says, destroyed the fear of Kali. And what was the weapon that Ramanujacharya used for this? It was the yantra called bhakti. In Visishtadvaita, the path to reach Sri Vaikuntha and to serve at the Lord's feet is prapatti, said P.B. Rangaramanujam in a discourse. That being the case, we should take the reference to bhakti here in this Rangaraja Stava verse as referring to prapatti.

For Visishtadvaitins, what is meant by bhakti is not what we usually understand as bhakti yoga. The bhakti that a Visishtadvaitin has, is a result of his prapatti. The nava vidha bhaktis are the fruits of his prapatti. They are the gifts given to him by Lord Narayana, because he has surrendered to Him. Prapatti is said to be one of the 32 Brahma vidyas. While following the other Brahma vidyas may not be possible for everyone, prapatti, by its very nature, is simple and can be resorted to by everyone. While praising Alavandar, Parasara Bhattar again uses the word bhakti. Before Alavandar's time, the Vedic path was strewn with thorns, making life difficult for those traversing that path, and Alavandar removed these thorns. But what were these thorns? They were the arguments of those who questioned the validity of the Vedas. Again, when he next talks about Nathamuni, Bhattar talks of bhakti. Here too, it should be taken to mean prapatti. Bhattar says that Nathamuni was like a cloud, which rained three things - disregard for anything other than the Lord; jnana about the nature of the Paramatma and love for the Lord.

With tricky jargons and complexities, the stock market is a labyrinth that often perplexes new investors. In the previous episode, we unravelled the jungle and highlighted a few animals and their behaviour. Now, we are untangling a few more from bourses.

Rapid Rabbits

Known for impulsive behaviour, scalpers and intra-day traders are the picture-perfect examples of nimble rabbits. Quite averse to overnight risk and aiming at instant profit, rabbits (traders, not investors) avoid holding a position even for a day. Often considered darlings of the brokerage firms for multiple entries and exits on a single day, they pay huge brokerage fee to the Depository Participants (DP). Dividend, return on equity, PE ratio are all not really up their alley.

For instance, Hari purchases 5,000 shares of Mannar & Co. at 9.32 a.m. for ₹125 and at 9.34 a.m., the price hits ₹125.20. Within two minutes, Hari would book a profit of ₹1,000 (5,000*0.20). In the same vein, he would make more entries and exits before the market closes on the day, booking small profit from each trade. This way, he makes considerable profit on a single trading day and also pay a hefty brokerage fee to the DP.

Thoughtful Turtles

For Turtles, market crashes are like water off a duck's back, they just shrug it off and move on. Jumping with joy, they consider the bearish market an opportunity to accumulate more shares. They remain unfazed by any bad news, short-term fluctuation or volatility in the market. The more the stock nosedives, the more they buy and keep on averaging it.

Let's assume Hari had purchased one share of Mannar & Co. for ₹125, after which the market crashed bringing the stock to ₹25. Instead of indulging in panic selling, prudent Hari bought five more stocks for ₹125. When the price was at a record high of ₹125, Hari could purchased only one but after the crash, he bought five. If the market remained bullish, Hari could buy only two shares for ₹250. But, Hari's portfolio now has six shares costing ₹250, thanks to market crash and averaging

Oblivious Ostriches

When faced with danger, an ostrich buries its head into the sand.
Likewise, these investors turn a
Nelson's eye to any bad news in the market, in the hope the news would disappear on its own. They just blindly believe that "all is well", when really "all is not well."

Let's assume an Ostrich investor heard it through the grapevine that Mannar & Co. will pull the curtain down soon, and that's the reason its shares fell like ninepins from ₹125 to ₹25. Despite this insight, this investor doesn't sell and realise at least ₹25 per share. Instead, he believes, often without valid reason, the news is not true and the stock would recover soon. Alas! The news would be true and the entire money is lost forever.

Speculative Stags

Stag investors, otherwise dubbed as IPO opportunists, are speculators who eye on making quick profit, predominantly in the IPO markets. They are often compared with deer for speed in execution of the strategy. They are not average Joes who easily settle down with the usual bullish or bearish markets. Day traders, they target quick bucks as soon as a stock is listed on the bourse. Generally, IPOs of the most reputable companies are oversubscribed and stocks allotted only to limited number of applicants. Hence, stags cash in on the opportunity. They apply for a bulk number of shares during the IPO and the moment they are listed at a high price, they offload them and exit.

These forest friends are metaphors that shed insights on trading/investing strategies in the stock market and by now, we hope you know which kind of investor or trader you are.

SIP: pause and restart, or continue?

Continuing your SIPs is optimal despite the downside risk; that said, reducing your equity exposure during the last five years of the time horizon for your life goal is very important

Some critics argue that systematic investment plans (SIPs) expose your investments to high risk when market valuations are rich. In this article, we discuss why SIP is optimal for most individuals despite its inherent risk.

Market timing

Goal-based portfolios typically have a long-term horizon. Continually timing the market for multiple goals may require lot of time and effort. Also, the more frequently you try to time the market for multiple investments, the more you are likely to risk making suboptimal decisions. Hence, the SIPs.

The tenure of an SIP on a passive equity fund must preferably match the time horizon for a life goal; the SIP for an active fund must be for 12 months at a time. The structure of an SIP is such that you will invest a fixed sum of money every month. This is behaviourally optimal because you are aware of the proportion of monthly savings that goes into your chosen equity fund. The automatic debit from your bank account means that you do not have to worry about forgetting to make the investment every month. But there is an issue.

Value averaging

Suppose you set up a monthly SIP for ₹20,000. You invest the same amount through the tenure of the SIP, whether the stock market has been continually moving up or down.

The argument that critics make is investing the same amount when the market is trending up exposes your investment to high risk. After all, if stocks are on a consistent uptrend, they are more likely to take a dive when the momentum slows down. This is a valid argument. An alternative investment process called value averaging addresses this issue. But the process requires your continual involvement, unlike an SIP.

Conclusion

A study on market timing suggests that returns will be significantly lower if you miss the ten best trading days in a year. Likewise, your returns will be significantly better if you are not in the market during the ten worst days.

The issue is that you will know the ten best and worst days only in hindsight. Even if you get it right one year, can you bank on your skill and luck to stop and restart SIPs through the time horizon for all your goals?

That is why continuing your SIPs is optimal despite the downside risk. That said, reducing your equity exposure during the last five years of the time horizon for your life goal is very important.

Tens of thousands of mourners pour in for Nasrallah's funeral

Despite the loss of its leader, Hezbollah maintains a strong support base within Lebanon's Shia community by providing social and economic services; Araghchi says 'the path of resistance will continue'; Israel states 'the world is a better place'

ens of thousands of mourners dressed in black, some waving Hezbollah flags or carrying portraits of the group's slain leader Hassan Nasrallah, flocked to his funeral on Sunday in a stadium on the outskirts of Beirut.

The killing of the charismatic leader, who guided the Lebanese movement for more than three decades, dealt a heavy blow to the Iran-backed group's reputation as a fighting

But Hezbollah, which also played a major role in

the country's politics for decades, has long had a support base in the country's majority Shia Muslim community by providing social and economic services. Many men, women and children from Lebanon and beyond walked on foot in the biting cold to reach the site of the ceremony, delayed for security

reasons after Nasrallah's death in a massive Israeli strike on Hezbollah's south Beirut bastion in September 2024.

One of them was Umm Mahdi, 55, who had come "to see him (Nasrallah) one last time and see his shrine".

As the crowds gathered, Lebanese state media reported Israeli strikes on areas in Lebanon's south, including a location about 20 km from the border. Israel's military said it had struck in southern Leba-"several rocket non launchers that posed an imminent threat to Israeli civilians".

Hezbollah has invited

top Lebanese officials to the ceremony, with Iranian speaker of parliament, Mohammad Bagher Ghalibaf and Foreign Minister Ab-Araghchi attendance.

Mr. Araghchi, in a speech from Beirut, described the slain leaders as "two heroes of the resistance" and vowed that "the path of resistance will continue".

Meanwhile, Israel's Army on Sunday said "the world is a better place" on the day of the funeral for Nasrallah.

"Today is Hassan Nasrallah's funeral. Today the world is a better place," the Army posted on X.

Russia launches 'largest drone attack' on Ukraine: Zelenskyy

Ukraine's President Volodymyr Zelenskyy on Sunday said Russia launched over 200 drones in an overnight attack, the largest of the war, as he condemned Russia's "aerial terror" and called for unity among Ukraine's allies.

"Every day, our people stand against aerial terror," he wrote on X.

"On the eve of the third anniversary of the fullscale war, Russia launched 267 attack drones against Ukraine - the largest attack since Iranian drones began striking Ukrainian cities and villages."

Ukraine's Air Force said that 138 of the drones were downed and another 119 disappeared from radars after being jammed by electronic warfare, adding that Russia also launched

three ballistic missiles. Damage was reported in five regions of Ukraine.

Moscow has launched near-nightly massed drone attacks at Ukraine for months.

Mr. Zelenskyy said in total, nearly 1,150 attack drones, more than 1,400 guided aerial bombs and 35 missiles of various types, were launched by Russia at Ukraine in the past week. The President thanked those operating Ukraine's air defences, and called on the country's foreign allies to stand united to secure a "lasting peace".

'Ready to quit'

Mr. Zelenskyy said on Sunday that he was ready to quit as Ukraine's President if it meant Kyiv would be admitted to the NATO military alliance.

"If there is peace for Ukraine, if you really need me to leave my post, I am ready. ... I can exchange it for NATO," Mr. Zelenskyy told a Kyiv press conference.

Bangladesh to mark Feb. 25 as Military Martyrdom Day

Bangladesh will mark February 25 as National Military Martyrdom Day, the interim government of Dhaka announced on Sunday. The announcement formalises months-long discussion within the Mohammed Yunus-led government about the February 2009 Pilkhana killings of military officers in a failed mutiny by a section of the Bangladesh Rifles.

The decision of the government to create a new memorial day dedicated to the military casualties during the mutiny and the consequent crackdown led to social media discussion about the timing of the decision.

The mutineers had looted weapons and tried to launch a military coup but were crushed, which led to the death of 74 military personnel, out of which 57 were Army officers. The The decision to military casualties during 2009 mutiny has led to a debate in the country

mutiny was the last big rebellion by sections of the Bangladesh armed forces which has played an important role in the political evolution of the country.

The decision of Sunday comes just a day after February 21 when Bangladesh marks the martyrdom of the students who

died in police firing in 1952

during Pakistan rule.

Martyrdom of students

Since the martyrdom of students in Dhaka under police firing on February 21, 1952, February has been known as the month dedicated to the mother tongue of the region which subsequently became Bangladesh in 1971.

The interim governnent has been focused on ensuring a thorough investigation into the 2009 incident and in December a commission headed by A.L.M Fazlur Rahman was ordered to probe the incident. The mutiny was investigated during the Sheikh Hasina years and around 450 individuals were given punishments ranging from death sentence to varied jail terms. However, questions were raised about the trial during the Hasina regime

August 5, 2024. While the earlier investigations were focused on internal reasons, the current commission and various components of the interim government – especially the anti-Hasina agitators – have been raising the "foreign" angle to the mutiny, indicating that the investigation will probe angles that were earlier not ex-

Russia signs memorandum to build port in Myanmar

Myanmar and its close ally Russia signed a memorandum on investment cooperation in a special economic zone in Dawei, including construction of a port and an oil refinery, Russia's Ministry of Economic Development said on Sunday.

The document was signed by the head of the Russian Ministry Maxim Reshetnikov and Myanmar's Minister for Investment and Foreign Economic Relations Kan Zaw during a visit of a Russian delegation to the southeast Asian country.

According to the Russian Ministry, the Dawei special economic zone is a 196 sq. km project in the Andaman Sea which is planned to house high-tech industrial zones and transport hubs, IT zones and export processing zones.

Israel ramps up West Bank offensive, says troops to remain in some areas for a year

Israel's Defence Minister said on Sunday troops would remain "for the coming year" in parts of the occupied West Bank where they have launched a weeks-long offensive and would prevent tens of thousands of displaced Palestinians from returning, as Israel deepens its crackdown on the Palestinian territory.

Israel launched a broad

West Bank on January 21 two days after the ceasefire that paused the war in Gaza took hold - and then expanded it to include other nearby areas. Israel says it is determined to stamp out militancy amid a rise in attacks. Palestinians view such raids as part of an effort to cement Israeli control over the territory, where 3 million Palestinians live under military rule. The raids have been deadly, caused destruction

to urban areas and displaced tens of thousands. Israeli Defence Minister Israel Katz said he had in-

structed the military to prepare to remain in some of the West Bank's urban refugee camps, where he said 40.000 Palestinians had fled – a figure confirmed by the United Nations leaving the areas "emptied of residents".

He said in a statement he had ordered the military to "prepare for an extended stay in the camps that were cleared for the coming year and to not allow return of residents".

akistan was the home' team for its ter against India. But, in front of a near sell-out crowd - more than threefourths decked in blue -Mohammad Rizwan's men were witness to a Virat Kohli masterclass as he reaffirmed his status as one of the greatest ODI batters.

The 36-year-old's brilliant unbeaten 100 (111b, 7x4) powered the Men in Blue to a comprehensive six-wicket win in their second league match (Group-A) of the ICC Champions Trophy at the Dubai International Cricket Stadium on Sunday.

Chasing a target of 242, skipper Rohit Sharma and Shubman Gill lit the fireworks before Kohli took centrestage. From the moment he hit two trademark cover drives in an over off Haris Rauf, the No. 3 batter showed he meant business.

Kohli, who has struggled against the tweakers in recent times, looked far more assured against Pakistan's thin spin attack, rotating the strike comfortably. He was dominant against the pacers, pulling Rauf to the

fine-leg fence and reaching his half-century by lofting Naseem Shah over cover.

In Shreyas Iyer (56), Kohli found an able ally. The duo's 114-run stand for the third wicket took the game away from the opponent.

Gill flourishes

Pakistan's only chance to make a fight of it was by taking early wickets, but Gill extinguished those hopes by smashing left-arm pacer Shaheen Afridi for seven boundaries. The opener threaded the ball through the cover region, pulled with power on the leg-side and executed a copy-book straight drive.

Earlier, the Pakistan ters blew hot and cold. After choosing to take guard first, a promising platform came undone in the middle and finished in a moderate 241. Saud Shakeel's halfcentury and Khushdil Shah's final flourish were the bright spots in an otherwise inconsistent and disappointing effort.

On a two-paced surface, Pakistan played too many dot balls (80 in the first 20 overs) against a disciplined Indian bowling attack.

Babar Azam provided a good start, producing pristine drives through the offside. At the other end, Imam-ul-Haq gobbled up deliveries in the PowerPlay without hitting a single boundary and was left stranded while going for a non-existent single.

After Babar departed, Shakeel and skipper Mohammed Rizwan (46) forged a 104-run alliance for the third wicket.

On a day when Virat Kohli hogged the limelight, Shrevas Iver went about his job unassumingly, playing perfect foil to his senior partner.

The Mumbai batter was pleased with the way he went about his business.

"Initially, I was struggling a bit to manoeuvre the ball through the gaps. I think Abrar (Ahmed) bowled brilliantly. It was important and crucial for me to play out that spell and, at the same time, rotate the strike," said Shreyas.

With a Flick, Barcelona regains control of the title race

After a dazzling start to the campaign, a youthful and inexperienced Barca lost the plot for a while; however, guided by coach Flick's German efficiency, it has achieved what looked unthinkable during the slump: a return to the top of the standings

erman pragmatism and discipline. FC Barcelona's traditional, expressive fair. On paper, there shouldn't be a sync between the two. At least, not as much as

When Hansi Flick was named as Xavi ernandez's successor, even the most optimistic of fans wouldn't have imagined the team to be as explosive and entertaining as it has. Barcelona has scored 116 goals across all competitions this season so far, six more than the 110 goals it managed in 2023-24.

In fact, the last time the Catalan club scored more goals (125 in 2020-21), Lionel Messi was running rampant in Europe.

It's streak this season? Incredible. The

Maximising potential

underlying numbers? Delicious.

Flick won seven titles, including two Bundesligas and a Champions League, in his two seasons at Bayern Munich. While he had all the right credentials and looked like a good bet for Barcelona, he had also walked into a chaotic club that finished a distant second to Real Madrid in 2023-24.

When the former German national team head coach landed in Spain, he inherited a club that was pinching pennies. The Blaugrana did its best all summer to recruit Nico Williams before it had to give up due to its inability to meet the financial demands of the transfer.

And when it did manage to sign a player, Dani Olmo from RB Leipzig, what followed was a long, tiring saga to register him. At the same time, arch rival Real Madrid, ironically, was polishing the latest jewel in its Galacticos 2.0 crown - Kylian

With resources lacking, Flick turned to the only options he had: making the most of the players at his disposal and dipping into La Masia to unearth the next generational star. Or two.

While many a million were needed to sign Robert Lewandowski, Jules Kounde and Raphinha, the rest of the star cast all have the 'Barca DNA' in them. They all came through the club's famed youth system that has time and again produced some of the most technically gifted players in the world.

Pau Cubarsi, Pedri, Alejandro Balde, Lamine Yamal, Marc Casado, Fermin Lopez, Gavi and Hector Fort. A group that has four teenagers, with the oldest being the 22-year-old Pedri.

Combine that youthful energy and explosive style, and you get a team that can run all night long and run up a cricket

Flick's go-to formation has been the 4-2-3-1, which changes to 4-3-3 according to how the contest unfolds. A compact midfield, relentless pressing, and using the width. They have all been hallmarks of the latest chapter in the club's glorious history.

Over the years, and especially since Pep Guardiola's time at the helm, Barca has enjoyed keeping the ball and dictating the pace of matches, and it continues to do so. It has the highest average ball possession (67.44%) in the league, with only Real Madrid (61.29%) anywhere close to it.

Cubarsi and Inigo Martínez in the defence along with Pedri and Casado in the double pivot have given the team a solid base to build their tactics around. Short, slick passes (568 per game, only behind Real Madrid's 574) are preferred over long, raking, cross-field pings, of which there have been only 41 per game - the fewest in the league.

This season, Barcelona has played the most key passes (313), has the most touches in the opponent's box (817), has the best shot conversion ratio (1.62%), created the most big chances (115), and racked up the most xG (61.5).

Flick has also done well to improve the seasoned players in his squad. With fluid wide attackers around him and the freedom to find spaces between the lines, Lewandowski has also found a new lease of life. The 36-year-old, who scored 42 goals in 69 league matches before Flick's arrival, now has 20 after 24 matches.

The Pole isn't the only player who has seen his form improve. Raphinha, who was on the chopping block all summer, has 24 goals and 16 assists from 37 matches. For comparison, Vinicius Junior registered 25 goals and 12 assists in 2023-24, which he and Real Madrid deemed Ballon d'Or worthy, so much so that they collectively threw a hissy fit when he was beaten to the crown by Manchester City's Rodri.

Turn back the clock to the first week of November and there was an air of invincibility around FC Barcelona. After all, it had ended the previous month with two impressive back-to-back wins. The first was the 4-1 victory against the mighty

Bayern Munich in the UEFA Champions League. The Catalans then followed it with a 4-0 schooling of Real Madrid at the Santiago Bernabeu, which felt like a seminal moment in the club's run under

And just when it looked like the good times were about to roll again, they

Going off the rails

Despite the good run, the German coach was quick to temper expectations.

"A team's form fluctuates a lot over a long season. The important thing is to focus on winning the next match. The important thing is how we finish the season. We could say that our goal is to be in the top eight," he said in early November, almost prophetically.

After the Champions League win against Crvena Zvezda in the first week of November, Barca's league campaign nosedived. By the end of December, it lost four times and drew twice in six league outings - a run that ended with a 2-1 defeat at home to title rival Atletico.

The 1-1 draw with Getafe after the Christmas break meant Barcelona was on its joint-worst league run in its history: six points from eight games.

From leading the league by six points after matchday 12, Barcelona found itself eight points behind Real Madrid and six behind Atletico when the dust settled on the 18th round of fixtures.

It is the kind of form that normally derails campaigns, gets heads rolling, and brings talk of a 'much needed' squad overhaul. However, through it all, Flick kept faith – in himself and his players. He was the anchor that kept Barcelona's ship steady in choppy waters.

Post-Christmas cheer

Despite struggling in the league, Barcelona continued to do well in other competitions, including the Champions League. However, the team had also been dealing with a lot of injuries, both to key

players and some of its most promising youngsters.

The Christmas break came at the right time, as it not only gave Flick and the players to hit the reset button but also allowed the injured players to start making a comeback. This gave the German more options off the bench, and he hasn't been shy to use them.

Before November substitutions at or before halftime only thrice, and twice it was because of injuries (Marc-Andre ter Stegen and Ferran Torres). The other was a tactical switch that saw Lopez replaced by Frenkie De Jong before the start of the second half against Real Madrid, a move that resulted in one of Barca's best wins this season.

Now, with the infirmary empty, Flick has been more ruthless in making changes, changes that have almost always made a difference. Case in point the match against Sevilla on February 9, when Lopez replaced Gavi and ended up scoring with his first touch in a 4-1 win.

After the Christmas break, Barca won 16 points from a possible 18. Fortuitously, Real Madrid and Atletico Madrid began to drop points, seven and nine respectively, in the same period.

Just before Christmas, on December 21, Barca, which was once the runaway leader, lost the top spot in the table following the defeat to Atletico Madrid. 58 days later. after a 1-0 win against Rayo Vallecano, it regained control of the title race.

When the form dropped at the end of 2024, Barca continued to do what it does best: dominate possession, keep the passes ticking, and create chances. However, it lost its defensive stability while also finding it hard to find the back of the net at the other end. It was like a house party where the host got so obsessed with the decor and ambiance that he/she forgot to dance and have a good time.

Now, Flick's team is back to its efficient best while continuing to entertain. Will it run away with the title? Maybe not. Should you bet against it? Only if foolish.

stronomers are excited to be poring over the first ever detailed geological map of the moon's south polar region, where India's Chandrayaan-3 lunar module, Vikram, touched down on August 23, 2023.

The map is expected to throw new light on the moon's origin and evolution. Researchers from the Physical Research Laboratory (PRL) in Ahmedabad, Panjab University in Chandigarh, and the Laboratory for Electro-Optics Systems, Indian Space Research Organisation, Bengaluru, created the map using data from the rover Pragyan, which was deployed by Vikram on a nine-day mission to analyse the chemical composition of the regolith the loose rock fragments and dust that cover the lunar surface.

Solving the magma mystery

The cornucopia of geological information from the mission has helped scientists confirm what they always suspected: the moon harbours an underground ocean of molten rock, or primordial magma.

Data from previous missions, such as the US uncrewed Surveyor spacecraft, the crewed Apollo moonshots, and the robotic Russian Luna and Chinese Chang'e 3 probes, indicated the presence of such a sea of lava beneath the lunar


But the actual extent of magma on the moon was not known since all the available data came from landing sites near the lunar equatorial and mid-latitude regions, which are far away from the

Chandrayaan-3, however, was the first mission to land in a high-latitude polar region of the moon, 630 km from the south pole, and scientists considered it the best bet to solve the magma mystery. In September 2024, a team of lunar geologists from PRL announced that the Alpha Particle X-ray Spectrometer aboard the Pragyan rover had detected magma under the landing site.

This meant the ancient ocean of molten lava extended across the entire

A common origin

In fact, earth and the moon have had similar evolutionary trajectories, as is evident in the dynamics of the earth-moon system. The inclination, or tilt, of the moon's orbit is, for example, to the earth's rotation, and both bodies are similarly aligned to the ecliptic plane of the solar system. Their terrestrial and lunar geochemistries are also complementary, with both possessing several common isotopes, pointing to their origins from the same cloud of molten material.

Astronomers believe that some 4.5 billion years ago, when the planets of the solar system were coalescing out of the rubble floating around the sun, the young earth had collided with a massive planetary rock roughly the size of Mars. The resulting debris from the collision was flung outwards explosively before it cooled over millions of years. This proto-planetary material gradually solidified into a molten sphere that was eventually captured by the earth's gravity to become the moon we see today.

In those early millennia, the infant moon must have been pummelled by asteroids and space rocks, as is evidenced by its surface, which is studded with

numerous craters. The Vikram lander had touched down close to one of the oldest of these craters: the South Pole-Aitken Basin, which is also one of the largest impact craters in the Solar System.

Lunar craters are of great interest to astrogeologists, who study them to learn more about the evolution of impact craters elsewhere on the earth and on the inner planets of the solar system.

Cratering history

After the erstwhile Soviet Union's Luna 2 lander became the first probe to 'land' (it was intentionally crash-landed) on the moon way back in 1959, scores of robotic and crewed spacecraft from the U.S., China, India, Israel, Japan, and the European Space Agency have reached the moon's surface. These missions have also left spacecraft components and other waste items behind, littering the regolith.

It is largely unknown how the landers, rovers, and the dozen U.S. astronauts may have disturbed the regolith, which sustains the thin lunar atmosphere. The moon's exosphere was formed when space rocks and the solar wind, the stream of charged particles flowing outwards from the sun, kicked up the powdery dust from the lunar surface.

Scientists also worry about the contamination of lunar ice reserves by exhaust fumes from lunar landers. When a spacecraft touches down on the moon, the water vapour released from its engines spreads across the lunar surface and ends up freezing at the poles. This leads to inaccurate readings for scientist who are studying the presence and the distribution of lunar water ice. These concerns are bound to increase as more and more missions head for the moon and mining for lunar resources eventually becomes a reality.

Condensed matter: a big piece of physics

Condensed matter physics is one of the largest, most active branches of contemporary physics research. Simply speaking, scientists in this field study the properties and behaviour of solid and liquid matter. Not so simply speaking, scientists here are interested in the behaviour of large collections of particles that are interacting strongly with each other. Such interactions are optional and infrequent in

Because of its size and scope, condensed matter physics has numerous subcategories. For example, the branch of electronic condensed matter is concerned with how electrons behave in solids and liquids. Research on semiconductors would belong here. Likewise, magnetic condensed matter studies different kinds of magnets and magnetism. Soft matter physics studies objects that are easily deformed but not broken, like biological tissue. Nanoscience studies very small objects that can display both classical and quantum

properties in the same settings

Such research has already given us, among other things, modern computing, optical fibres, lasers, nanofabrication, and novel chemical reactions to synthesise new materials. Of late, researchers have also been exploring quantum condensed matter, where quantum physics processes enable very unusual behaviour not seen in macroscopic solids and liquids.
