


Agenda:

The members confirmed the Minutes of Meeting of Board of Studies in Teacher Education held on 28-08-2019, of which the minutes are already circulated.

2. Amendments in the Statutes of B.Ed & M.Ed under CBCS and on-CBCS as per guidelines of NCTE.

The members discussed the Statutes of B.Ed & M.Ed under CBCS And Non-CBCS as per guidelines of NCTE and the proposed amendments in accordance of NCTE were approved which are attached herewith. Members observed that the experimental School should be an integral part of B.Ed programme and members were dismayed that since long this issue has not been attended by the Colleges of Education. Inspection of the Colleges of Education to be in conformity with the NCTE norms. It was proposed that in Semester-I, the paper of Education in Indian Perspective is to be replaced by Indian Constitution & Education in Indian Perspective.



The Syllabus is modified accordingly and as such 30% of the change is done.

In Semester-II, there is an add on of two credits Compulsory Course titled 'Yoga Education' and the new syllabus is added accordingly. The B.Ed(Distance mode) Statutes will be in accordance of NCTEW regulations.


3. Amendments in the Statutes of BA B.Ed/B.Sc.B.Ed Programme and Integrated B.Ed M.Ed Programme in the light of NCTE guidelines.

The members took up amendments in the Statutes of BA B.Ed/B.Sc B.Ed Programme and Integrated B.Ed M.Ed Programme in the light of NCTE guidelines howsoever all be it on the basis of NCTE approval. Moreover, it was unanimously resolved that Statutes need to be revisited as per the observations of various Universities of the country wherein there is confusion regarding entry & exit of the degree of BA/B.Sc and integrated B.Ed, M.Ed. The office of CDC should seek the clarification of all Teacher Education Programmes from NCTE.

4. To review the syllabi and courses of studies in the subject of M.Ed(CBCS) and M.Ed Non-CBCS Scheme) for semester I to IV under Curriculum Reforms of RUSA 2.0 from the academic Session 2020-2021.

The members reviewed the Syllabi and the courses of Studies in the subject of M.Ed(CBCS) and (Non-CBCS Scheme) for semester I to IV as proposed by Curriculum Reforms Committee under RUSA 2.0 and it was proposed that from the academic Session 2020-2021, new amended Syllabi as per suggestion of the Curriculum Reforms Committee would be implemented.





Item No 1 : The Minutes of the Last meeting in BOSTE

The members approved the minutes of the Board of the studies in Teacher Education held on 05.03.2020.



Item No 2: The BPEd (NCBCS) & MPEd (CBCS) syllabus For the IIIrd & IVth Semester .

As per the suggestions of last BOSTE held in March 2020 , wherein it was proposed to the Dept of Physical Education should hold a workshop of the curriculum Reforms for the revision of the BPEd & MPEd Syllabus . But due to the COVID 19 pandemic , the proposed meeting could not take place on the scheduled time and the same meeting was held on 18th & 19th August 2020 which was attended by all the members of BOSTE as well as the experts from the other Universities through Virtual Mode. In this meeting the entire curriculum reforms exercise was undertaken in regard to BPEd (NCBCS) & MPED (CBCS). The amended syllabus was presented in this BOSTE which approved it & same is to be implemented for the examinations to be held in Dec 2020 onwards for the IIIrd & IVth Semesters.

Item No 3 : The BEd syllabus & its continuity

In regard to Item No 3, it was resolved that BEd Curriculum will continue for one another year but minor changes due to NEP 2020 need to be incorporated here:

- a) The Course No 101 will be known as Indian Constitution & Education in Indian Perspective instead of Education in Indian Perspectives in Ist Semester. Less than 25% of change in the syllabus related to the Constitutional Provisions was incorporated in course no 101. There is introduction of 2 Credits New Course No 207 (Yoga Education) for 50 marks in the IInd Semester. Besides to it, on the recommendations & suggestions of the members that the BEd Syllabus should be in tune with the NCTE as well as adopting the major recommendations of NPE , the reference of Teacher Education as per National Education Policy 2020 was added in the Teacher Education (Course No 401) in the Optional Course - History of Indian Education(402A) .





- b) It was also agreed & resolved that major transformation in the present curriculum would be undertaken taken as and when the recommendations of NCFTE which will be in place in accordance of the NEP 2020.
- c) It was also resolved that the minor changes being incorporated in the syllabus of BEd will be implemented from the session Sept 2020 & onwards ^{plus} for one year.

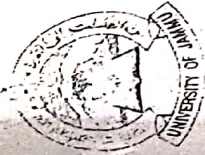

2. To review the syllabi and courses of studies in the subject of B.Ed. for Semesters I, II, III & IV for the examinations to be held in the years mentioned below:

B.Ed.


Semester-I December 2021, 2022 and 2023

The members unanimously resolved that as the syllabus of B.Ed. was revised in 2021, the same shall continue for semester I, II, III & IV for current academic session 2021. However, a workshop to review the entire syllabus will be held in the month of December with the members of BOS and also faculty members of Colleges of Education affiliated to University of Jammu in the light of NCTE & NEP 2020. The proposed date of workshop is 16th-17th December 2021.

The syllabus discussed and framed as per the RUSA 2.0 grant was finalized for the academic session mentioned above Semester-I December 2021, 2022 and 2023, Semester II May 2022, 2023 and 2024, Semester III December 2022, 2023 and 2024, Semester IV May 2023, 2024 and 2025 and enclosed herewith. Same syllabus will be applicable to the two Colleges of Education affiliated to University of Jammu running M.Ed. programme. These two colleges will run their M.Ed programme as per CBCS for which they will get in touch with University offsite campuses at Kathua and Udhampur or else explore SWAYAM platform.

However, a workshop to review the syllabus will be held in the month of December with the members of BOS and also faculty members of colleges of education affiliated to University of Jammu in the light of NCTE & NEP 2020. The proposed date of workshop is 20th December 2021.

7. To formulate the syllabi and course of studies in the subject of B.A.-B.Ed. Four Year Integrated Degree Programme for semester III, IV, V, VI, VII and VIII for the examinations to be held in the year 2021 onwards.

The syllabus of B.A.-B.Ed. Four Year Integrated Degree Programme syllabus was also discussed and the syllabus for semester III was finalized for the academic session December 2021 and May/December 2022 and enclosed. However the syllabus for semester I, II, IV, V, VI, VII & VIII will be taken up in a workshop in the month of December and finalised. The proposed date of workshop is 21st December 2021.

8. To review the syllabi and course in the subject of B.A.-B.Ed. Four Year Integrated Degree Programme for semester I & II for the examinations to be held in the year 2021 onwards.

The syllabus of B.A.-B.Ed. Four Year Integrated Degree Programme for semester I will continue in the current academic session 2021.

9. To prepare a panel of paper setters/examiners to be sent to the Controller of Examinations, University of Jammu, Jammu.

The Convener Board of Studies will prepare the panel to be sent to Controller of Examinations, University of Jammu.

10. To indicate the %age of change in the syllabi and courses of study mention in item no. 2,3,4,5 and 6 on each papers/course no.

The changes in the syllabi and courses of study mentioned in item no. 2,3,4,5 and 6 is less than 20%.



11. Any other item/s with the permission of the chair.

- i. In response to the proposal from Prof Parikshat Singh Manhas, Rector Udhampur Campus with the subject 'Request for Introducing Four Year Integrated Course in Education at Udhampur Campus, University of Jammu, it was resolved that since there is no Undergraduate programme running in the Udhampur Campus besides adhering to the norms of NCTE with regard to the faculty and infrastructure so that the process of approval from BOS in Teacher Education for the said course can be sought.
- ii. However, Three year Integrated B.Ed-M.Ed. Teacher Education programme can be initiated in the offsite campuses of Udhampur, Bhandarwah and Kathua in line with NCTE & NEP 2020.
- iii. Members unanimously resolved that regarding Grades for Bachelor of Special Education (ID) for MIER College of Education, these should be the same as the grades already applicable to the B.Ed course of the University of Jammu.

The convener shared the milestones in the Department of Education and future roadmap indicating activities to be taken up by the Department.
