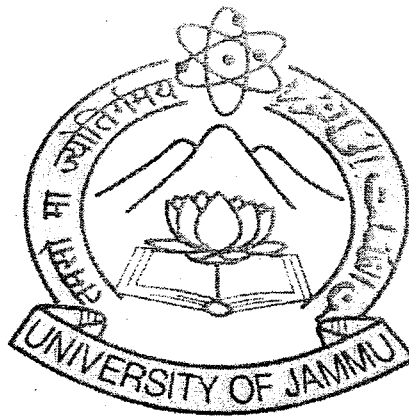






At the outset, the Hon'ble Chancellor, University of Jammu welcomed all the members of the University Council present in the meeting.

The Hon'ble Chancellor congratulated the Vice-Chancellor and entire University fraternity for becoming the first University of J&K, UT having secured A++ grade from the National Assessment and Accreditation Council (NAAC) with a CGPA of 3.72. He complimented the University's efforts towards fostering academic excellence, innovative work and holistic development of students. He noted with satisfaction University's jump in NIRF ranking from 63 to 50. He observed that the true challenge now lies in maintaining and upholding the standards in future as well.

The Hon'ble Chancellor emphasized the following specific points:

- The University must undertake regular revision of curriculum and courses besides introducing new courses in line with the emerging trends, modern day techniques and needs and demands of the society.
- Both the University of Jammu and University of Kashmir must take requisite measures for introduction of Under-Graduate Courses in the Main Campus at the earliest.
- The University must expedite the appointment process to fill up the vacant Teaching / Non-Teaching posts in a fast track mode to strengthen its academic, research and administrative activities. He enjoined upon the University to ensure that the exercise to address all remaining cases under Career Advancement Scheme (CAS) is completed within a period of next three months.
- The University must lay dedicated focus on promotion of local languages and culture of the region by involving the participation of eminent personalities in the concerned fields.
- The reservation policy of J&K Government should be adopted by all the Universities of the UT in totality with all its subsequent amendments.
- University must ensure completion of all the infrastructure projects undertaken by it within the stipulated time frame with strict adherence to the quality standards.
- The e-office should be implemented in a time bound manner with biometric attendance being made compulsory for all the University employees.
- University should hold regular meetings of the University Council which must be held twice a year.
- For the effective and smooth functioning of the off-site campuses of the University of Jammu, the Additional Chief Secretary to Government, Higher Education Department, J&K and Vice Chancellor, University of Jammu should deliberate and work out the modalities for creation of teaching/administrative positions for the University's Off-site Campuses keeping in view the immediate requirements and associated financial implications.
- The University of Jammu had set up the Gandhian Centre for Peace and Conflict Studies, Maharaja Ghulab Singh Chair and Guru Nanak Dev Chair of Sufi Studies to promote the research in the respective areas of focus. The Hon'ble Chancellor emphasized the importance



of conducting research and activities under these initiatives. Moreover, the financial assistance/grant related matters must be taken up by the University with the concerned Departments of UT of J&K Government at the earliest.

- In future, only such items as have been duly recommended/ endorsed by the relevant statutory bodies of the University like the Finance Committee, the Academic Council and University Syndicate shall be brought before the University Council for its consideration.
